

TO INTERESTED PERSONS HAVING THE RIGHT TO SIGN AN APPLICATION FOR THE APPROVAL BY REFERENDUM

SECOND DRAFT RESOLUTION NUMBER CA10 20 0457

1. PURPOSE OF THE DRAFT AND APPROVAL BY REFERENDUM

Following the public consultation meeting held on August 16, 2010, the Council has adopted a second draft resolution bearing number CA10 20 0457 in conformity with the provisions of the *Bylaw concerning specific construction, alteration or occupancy proposals for an immovable* (LAS-0041).

The purpose of this particular project is to authorize the occupation of the building located at 381 to 389, 90e Avenue for the purposes of habitation for eight (8) dwellings, and this, in spite of articles 3.5.1 and 5.3.7 k) of zoning bylaw 2098 related to the use and to the parking spaces.

This second draft contains provisions that could be the object of an application by interested persons in the zone concerned and contiguous zones such that a bylaw that contains them be submitted for their approval in conformity with The Act Respecting Elections and Referendums in Municipalities.

An application relative to these dispositions may originate from zone H06-19 and from contiguous zones H06-17, H06-14, H06-13, C06-12, H06-11, P06-20 and P06-18.

Such an application intends that the resolution containing these provisions be submitted for the approval of those persons qualified to vote in the zone to which it applies and the contiguous zone from which a valid application is submitted, with regard to the provision.

2. CONDITIONS FOR A VALID APPLICATION

To be valid, an application must:

- indicate the provision being addressed, and the zone from which it is submitted and should the case arise indicate the zone from which the application is made;
- be received at the office of the *Secrétaire d'arrondissement* no later than September 3, 2010, 12 p.m.;
- be signed by at least 12 interested persons from the zone from which the application is submitted, or at least the majority of them if the number of interested persons in the zone does not exceed 21.

3. INTERESTED PERSONS

Information required to determine who are the interested persons having the right to sign an application and the manner in which a legal person may exercise the right to sign an application may be obtained at the office of the *Secrétaire d'arrondissement*, 55 avenue Dupras, LaSalle, during business hours.

4. ABSENCE OF APPLICATIONS

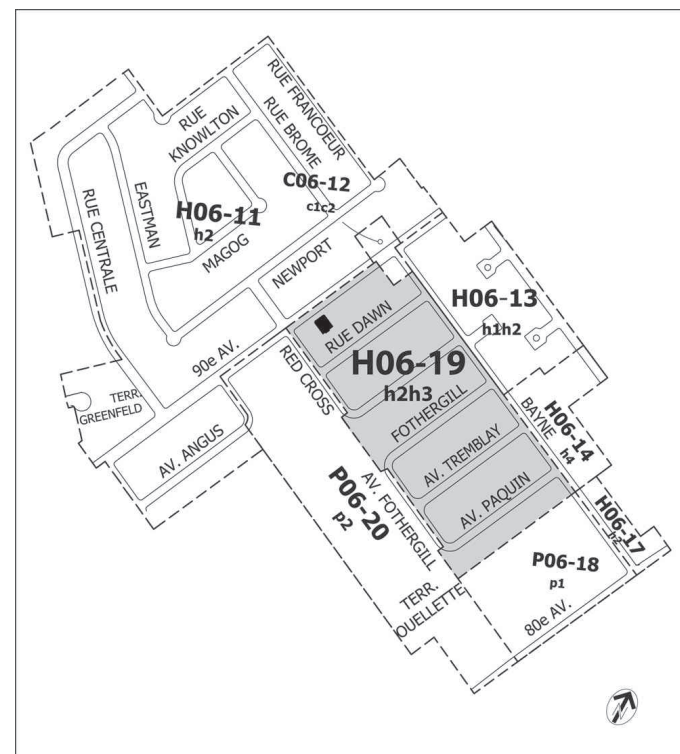
All provisions of the second draft that are not subject to any valid application can be included in the bylaw that will not require approval by eligible voters.
