



## COMING INTO FORCE OF BY-LAWS

Notice is given that the following by-laws were adopted at the city council meeting of August 23, 2010:

- 10-019**      **Règlement sur la subvention aux artistes professionnels des arts visuels et des métiers d'art (exercice financier 2010)**  
[By-law concerning subsidies for professional artists in visual arts, and in arts and crafts (Fiscal 2010)]
- 10-020**      **Règlement sur les parcs relevant de la compétence du conseil municipal de la Ville de Montréal**  
[By-law concerning parks under the authority of Montréal city council Entire territory – Central city]  
The object is to replace R.B.C.M., c. P-3 for the following parks: Angrignon, Cité du Havre, Jarry, Jeanne-Mance, La Fontaine, Maisonneuve including the municipal golf course, Promenade-Bellerive, des Rapides and René-Lévesque.
- 04-047-94**    **Règlement modifiant le Plan d'urbanisme de la Ville de Montréal (04-047)** [Quartier Parc-Extension]  
The object is to amend land-use designation, to identify the sector concerned as "mixed-use". Moreover, the by-law amends the construction density plan, so as to authorize for this new sector a building of three to ten storeys, a moderate to high land coverage ratio, and an occupancy ratio between 2 and 5.
- 10-018**      **Règlement relatif à la cession pour fins d'établissement, de maintien et d'amélioration de parcs, de terrains de jeux et de préservation d'espaces naturels sur le territoire de l'arrondissement de LaSalle**  
[By-law concerning the transfer for the establishment, maintenance and enhancement of parks and playgrounds, and the preservation of natural spaces, on the territory of LaSalle borough]
- 09-027**      **Règlement autorisant la construction et la transformation de bâtiment sur les lots situés au nord-ouest de l'intersection du boulevard René-Lévesque et de la rue Mackay et portant les numéros 1 066 189, 1 066 192, 1 066 193, 1 066 194, 1 066 507, 1 066 510 et 1 067 432 du cadastre officiel du Québec**  
[By-law authorizing the construction and conversion of the building located on the lots north-west of the intersection of Boulevard René-Lévesque and Rue Mackay, and bearing numbers 1 066 189, 1 066 192, 1 066 193, 1 066 194, 1 066 507, 1 066 510 and 1 067 432, official cadastre of Québec]
