## **PUBLIC NOTICE UNDER SECTION 192 OF SCHEDULE C TO THE CHARTER OF VILLE DE MONTRÉAL**

### **Third notice**

At its December 2, 2010 meeting, the executive committee approved the following description of immovables that the city intends to acquire under section 192 of schedule C to the charter:

- A lane made up of lot 1 881 390, cadastre of Quebec, located in the quadrilateral bounded by Rue Ontario Est, Rue Théodore, Rue La Fontaine and Rue Leclaire in Mercier-Hochelaga-Maisonneuve borough, having an area of 426.4 m<sup>2</sup>.
- A lane made up of lot 1 880 549, cadastre of Quebec, located in the quadrilateral bounded by Rue de Rouen, Avenue de La Salle, Rue Ontario Est and Avenue Desjardins in Mercier-Hochelaga-Maisonneuve borough, having an area of 186.3 m<sup>2</sup>.
- A lane made up of lot 1 881 660, cadastre of Quebec, located in the quadrilateral bounded by Avenue Pierre-de-Coubertin, and Rue Théodore, Rue Hochelaga and Rue Leclaire in Mercier-Hochelaga-Maisonneuve borough, having an area of 990.5 m<sup>2</sup>.
- A lane made up of lot 1 880 814, cadastre of Québec, located in the quadrilateral bounded by Rue Sainte-Catherine Est, Avenue d'Orléans, Rue Notre-Dame Est and Avenue Bourbonnière in Mercier-Hochelaga-Maisonneuve borough, having an area of 299.2 m<sup>2</sup>.
- A lane made up of lot 1 879 666, cadastre of Quebec, located in the quadrilateral bounded by Rue Dandurand, Avenue Jeanne-d'Arc, Rue Masson and Avenue Charlemagne in Rosemont-La Petite-Patrie borough, having an area of 433.8 m<sup>2</sup>.
- A lane made up of lot 1 878 554, cadastre of Quebec, located in the quadrilateral bounded by Rue de Rouen, Rue Sicard, Rue Hochelaga and Rue Leclaire in Mercier-Hochelaga-Maisonneuve borough, having an area of 343.4 m<sup>2</sup>.

The owners of immovables expropriated under that section may claim an indemnity from the city. If no agreement is reached, the indemnity is set by the Tribunal administratif du Québec, at the owner's or at the city's request, and sections 58 to 68 of the Expropriation Act (R.S.Q., chapter E-24) apply, adapted as required.

This is the third of three notices to be published by the city.
