Notice is given that the following by-laws were adopted at the city council meeting of December 19, 2011:

- 11-042**            **Règlement autorisant un emprunt de 15 000 000 \$ afin de financer l'aménagement et réaménagement des lieux d'élimination de neige et l'amélioration des équipements**  
*(By-law authorizing a loan of \$15,000,000 for the development and redevelopment of snow disposal locations and for the improvement of equipment)*
- 11-043**            **Règlement autorisant un emprunt de 15 000 000 \$ afin de financer l'achat de feux de circulation, d'équipements de signalisation et de lampadaires**  
*(By-law authorizing a loan of \$15,000,000 for the purchase of traffic lights, signaling equipment and streetlamps)*
- 11-044**            **Règlement autorisant un emprunt de 30 000 000 \$ afin de financer des travaux visant la protection des immeubles**  
*(By-law authorizing a loan of \$30,000,000 for work for the protection of immovables)*

The following by-laws were adopted at the urban agglomeration council meeting of December 22, 2011:

- RCG 11-027**      **Règlement autorisant un emprunt de 10 000 000 \$ afin de financer l'achat de feux de circulation, d'équipements de signalisation routière et lampadaires**  
*(By-law authorizing a loan of \$10,000,000 for the purchase of traffic lights, road signaling equipment and streetlamps)*
- RCG 11-028**      **Règlement autorisant un emprunt de 25 000 000 \$ afin de financer l'acquisition d'équipements et de services professionnels en informatique**  
*(By-law authorizing a loan of \$25,000,000 for the acquisition of information technology equipment and professional services)*
- RCG 11-029**      **Règlement autorisant un emprunt de 30 000 000 \$ afin de financer l'achat de véhicules et leurs équipements**  
*(By-law authorizing a loan of \$30,000,000 for the purchase of vehicles and related equipment)*

**RCG 11-030      Règlement autorisant un emprunt de 30 000 000 \$ afin de financer des travaux d'aménagement et de construction de pistes cyclables**

*(By-law authorizing a loan of \$30,000,000 to finance development and construction work on cycling paths)*

**RCG 11-031      Règlement autorisant un emprunt de 35 000 000 \$ afin de financer des travaux d'aménagement dans les parcs**

*(By-law authorizing a loan of \$35,000,000 for development work in parks)*

By-laws 11-042, 11-043 and 11-044 were approved by the minister of municipal affairs, regions and land occupancy on January 30, 2012, whereas by-laws RCG 11-027, RCG 11-028, RCG 11-029, RCG 11-030 and RCG 11-031 were approved on February 1, 2012. All these by-laws come into force on February 7, 2012 and may be consulted during regular office hours at the Direction du greffe, 275, rue Notre-Dame Est.
