TO ALL INDIVIDUALS CONCERNED BY DRAFT RESOLUTION CA12 210043 ENTITLED "ADOPT, UNDER THE BYLAW CONCERNING SPECIFIC CONSTRUCTION, ALTERATION OR OCCUPANCY PROPOSALS FOR AN IMMOVABLE, A RESOLUTION TO ALLOW THE CONSTRUCTION OF 32 CONDO UNITS IN A FOUR-STOREY BUILDING ON LOT 1 183 750 (252, RUE GORDON):

- 1. TO authorize the construction of thirty-two (32) condo units in a four- (4-) storey building, in an "h4 multi-family housing" group of uses, on lot 1 183 750 (252, rue Gordon);
- 2. TO allow an exemption to Table of Uses and Norms H02-30 of Zoning Bylaw 1700, so that the number of condo units may be greater than the maximum authorized;
- 3. TO allow an exemption to Table of Uses and Norms H02-30 of Zoning Bylaw 1700, so that the building may be isolated;
- 4. TO allow an exemption to Table of Uses and Norms H02-30 of Zoning Bylaw 1700, so that the rear setback of the building may be less than the minimum required;
- 5. TO allow an exemption to Table of Uses and Norms H02-30 of Zoning Bylaw 1700, so that the land-use ratio may be greater than the maximum authorized;
- 6. TO authorize an exemption to article 203 of Zoning Bylaw 1700, so that one of the condo units may be allowed not to have a balcony;
- 7. TO subject the authorization provided for under article 1 to the following conditions:
 - that two three-bedroom units be included in the project;
 - that the height of the building be in keeping with the height stipulated on the elevation plans."
