A-19.1).

THAT the object of draft by-law CA29 0041-1 is to repeal section 31 entitled “Deep Landsites”.

THAT the object of draft by-law CA29 0041-2 is to repeal section 35 entitled “Route of a thoroughfare in proximity to a lake or a watercourse”.

THAT said projects affect the whole territory of the borough of Pierrefonds-Roxboro.

THAT in the course of this public meeting, the Mayor of the Borough or another member of the council will explain the draft by-laws and the consequences of their adoption, and also hear parties who wish to express their concerns.

THAT draft by-law CA29 0041-1 contains a provision relating to a by-law that is susceptible to be approved by referendum.

THAT draft by-law CA29 0041-2 does not contain provisions relating to a by-law that is susceptible to be approved by referendum.
