BY-LAW CONCERNING THE TRAFFIC AND RESTRICTION OF HEAVY
VEHICLES LOADS ON THE BRIDGE OF BOULEVARD PITFIELD, NORTH
DIRECTION IN THE BOROUGH OF PIERREFONDS-ROXBORO

At a regular council sitting of the Borough of Pierrefonds-Roxboro held in the council room located at 13,665 boulevard de Pierrefonds, in said Borough, on March 5, 2012 at 7 p.m., in conformity with the Cities and Towns' Act (RSQ., Chapter C-19), at which were present:

All members of the Council and forming a quorum under the chairmanship of the Mayor of the Borough, Mrs. Monique Worth.

Mr. Jacques Chan, Director of the Borough, was present and acted as Substitute Secretary of the Borough in the absence of Me Suzanne Corbeil.

IN VIEW of Section 291 of the Highway Safety Code (R.S.Q., c. C-24.2);

IN VIEW of Section 66 of Municipal Powers Act (R.S.Q., c. C-47-1);

IN VIEW of Section 105 of the Charte de la Ville de Montréal (R.S.Q., c. C-11.4);

IN VIEW of Ville de Montréal by-law concerning the delegation to borough councils of certain powers relating to the arterial road system (08-055);

WHEREAS a notice of motion for the present by-law was given on the Borough regular sitting held on January 16, 2012;

THE BOROUGH COUNCIL ENACTS THE FOLLOWING:

ARTICLE 1 For the purposes of this by-law, a heavy vehicle is a truck under the meaning of the Regulation respecting road signage (c. C-24.2, 4. 41) or any type of similar vehicles;

ARTICLE 2 The traffic of a heavy vehicle is prohibited or restricted according to road signs that are installed in accordance with Appendix A attached hereof.

ARTICLE 3 The present by-law replaces the by-law concerning the traffic and restriction of heavy vehicles loads on the bridge of boulevard Pitfield, North direction in the borough of Pierrefonds-Roxboro (CA29 0056).
