

CALL FOR APPLICATIONS

WORKING COMMITTEE ON THE FUTURE RESIDENTIAL USE OF THE HIPPODROME DE MONTRÉAL PROPERTY AND SURROUNDING LAND

The Côte-des-Neiges—Notre-Dame-de-Grâce borough wishes to add three new members to the eight current members of the Working committee on the future residential use of the Hippodrome de Montréal property and surrounding land (the Committee).

The Committee's main mission is to discuss issues relating to the former Hippodrome de Montréal site sector, to study and submit recommendations to the Borough Council on development options and strategies in this sector, in particular as concerns promoting social housing.

The reason for expanding the Committee to eleven members is to consider in greater depth the issues related to the accelerated development of the Triangle sector, next to the Hippodrome de Montréal property and bounded by rue de la Savane to the north, the Canadian Pacific Railway line to the south, rue Mountain Sights to the west and rue Victoria to the east.

The three new members will represent, respectively:

- new residents in the Triangle sector
- a community organization working in the Triangle sector
- the Côte-des-Neiges—Notre-Dame-de-Grâce borough community

Generally speaking, to fill one of the three positions applicants must:

- have a good knowledge of French
- be available for committee meetings and hearings
- be familiar with municipal issues
- be familiar with the area

More specifically, applicants wishing to represent new residents in the Triangle sector must:

- live in the borough, in the new property development in the Triangle sector

Applicants wishing to represent a community organization working in the Triangle sector must:

- belong to a community organization serving the Triangle sector
- be involved in the community
- have been actively involved in one or more of the economic, cultural, scientific, community or educational sectors in Montréal

Applicants wishing to represent the Côte-des-Neiges—Notre-Dame-de-Grâce borough community must:

- live in the borough or belong to a community organization serving the borough
- possess expertise or have been actively involved in one or more of the economic, cultural, scientific, community or educational sectors in Montréal
