THAT the object of draft by-law is to authorize the construction of detached multifamily building "H3" of 3 to 6 storeys (plus mezzanines) on the site formed by lots 1 841 738 (14750-14762, boulevard Gouin Ouest – H3-4-265 zone), 1 841 740 (14700-14706, boulevard Gouin Ouest – H1-4-262 zone), lot 1 841 632 (14784-14790, boulevard Gouin Ouest – H3-4-261 zone) of the cadastre of Quebec, of a maximum of 115 dwelling units, by virtue of by-law CA29 0045 concerning specific construction and occupancy proposals for an immovable
