COMING INTO FORCE OF BY-LAWS**

Notice is given that the following by-laws were adopted at the city council meeting of September 23, 2013:

- 13-038** **Règlement autorisant un emprunt de 9 400 000 \$ pour le financement du réaménagement du domaine public et de l'acquisition de terrains à des fins de parcs et places publiques dans le secteur Griffintown**
[By-law authorizing a loan of \$9,400,000 for the redevelopment of public property and the acquisition of land for the purposes of parks and public places in the Griffintown sector]
- 13-041** **Règlement autorisant un emprunt de 10 000 000 \$ afin de financer l'achat de véhicules et leurs équipements**
[By-law authorizing a loan of \$10,000,000 for the purchase of vehicles and related equipment]
- 13-042** **Règlement autorisant un emprunt de 10 000 000 \$ pour le financement de travaux d'aménagement de parcs**
[By-law authorizing a loan of \$10,000,000 for park development work]
- 13-043** **Règlement autorisant un emprunt de 25 000 000 \$ afin de financer les travaux de rénovation et de protection des immeubles**
[By-law authorizing a loan of \$25,000,000 for the renovation and protection of immovables]
- 13-044** **Règlement autorisant un emprunt de 30 000 000 \$ afin de financer l'acquisition d'équipements et de services professionnels en informatique**
[By-law authorizing a loan of \$30,000,000 for the acquisition of information technology equipment and professional services]
- 13-045** **Règlement autorisant un emprunt de 45 000 000 \$ afin de financer la réfection, la reconstruction et le réaménagement de structures routières (ponts, tunnels, viaducs et murs)**
[By-law authorizing a loan of \$45,000,000 for the renewal, reconstruction and redevelopment of road structures (bridges, tunnels, overpasses and walls)]

[By-law authorizing a loan of \$45,000,000 for the acquisition of road signaling equipment as well as streetlights]
- 13-047** **Règlement autorisant un emprunt de 50 000 000 \$ pour le financement de travaux de réfection routière du réseau artériel**
[By-law authorizing a loan of \$50,000,000 for road renewal work on the arterial road network]
- 13-048** **Règlement autorisant un emprunt de 30 000 000 \$ afin de financer les travaux de réfection du réseau routier local ainsi que la réfection des rues collectrices locales**
[By-law authorizing a loan of \$30,000,000 for renewal work on the arterial road network as well as the renewal of local collector roads]

These by-laws were approved by the Minister of Municipal Affairs, Regions and Land Occupancy on October 22, 2013. They come into force on October 28, 2013, however by-laws 13-041, 13-042, 13-043, 13-044, 13-045, 13-046 13-047 and 13-048 take effect on January 1, 2014.
