CONCORDANCE BY-LAW MODIFYING ZONING BY-LAW CA29 0040 OF THE BOROUGH OF PIERREFONDS-ROXBORO IN ORDER TO ADD TO THE LIST OF DOCUMENTS OF APPENDIX “E” ALLOWING TO IDENTIFY THE FLOOD ZONES OF GREAT CURRENT (RECURRENCE 0-20 YEARS) AND THE FLOOD ZONES OF LOW CURRENT (RECURRENCE 20-100 YEARS) THE EXEMPTION DOCUMENTS TO THE FLOOD PLAIN AND TO ADD TO APPENDIX “E” THE EXEMPTION DOCUMENTS CONCERNING SPECIFICALLY THE BOULEVARD LALANDE HEIGHTENING

NOTICE is hereby given by the undersigned:

THAT the Borough Council, following the adoption by resolution number CA15 29 0066 at the regular sitting held on March 2, 2015 of the draft by-law entitled as hereinabove, will hold a public consultation meeting on **Tuesday, April 7, 2015, at 6:30 p.m.**, in the council room, 13665, boulevard de Pierrefonds, in conformity with the provisions of the Act respecting land use planning and development (R.S.Q. c. A-19.1).

THAT the object of draft by-law is to add to the list of documents of Appendix “E” allowing to identify the flood zones of great current (recurrence 0-20 years) and the flood zones of low current (recurrence 20-100 years), the exemption documents to the flood plain and to add to Appendix “E” the exemption documents concerning specifically the boulevard Lalande heightening.

THAT in the course of this public meeting the Mayor of the Borough or another member of the Council will explain this draft by-law and the consequences of its adoption, and also hear parties who wish to express their concerns.

THAT this draft by-law does not contain provisions relating to a by-law that is susceptible to be approved by referendum.

THAT this draft by-law is available for examination at the Borough Secretary's Office, Monday to Thursday, from 8 a.m. to noon and from 1 p.m. to 4:45 p.m. and Friday from 8 a.m. to noon.
