PUBLIC NOTICE COMING INTO FORCE OF BY-LAWS

Notice is hereby given that the following by-law was adopted at the urban agglomeration council meeting of April 30, 2008:

RCG 08-016 Règlement modifiant le Règlement sur le régime de retraite des employés assujettis à une convention collective de travail de la Ville d'Outremont (1292 et ses modifications)

The amendments to the above-mentioned by-law concerning the pension plan of unionized Outremont employees consist namely of those required by law in addition to provisions for the division and merger to the absorbing Montreal pension plan, as of December 31, 2007, of assets and liabilities attributable to the group of firefighters. The Régie des rentes du Québec (RRQ) authorized the merger and registered the amendments, as required by the Supplemental Pension Plans Act (CQLR, c. R-15.1), on April 7, 2015.

The following by-law was adopted at the urban agglomeration council meeting of August 26, 2010:

RCG 10-015 Règlement modifiant le Règlement concernant le régime complémentaire de retraite des employés de la Ville d'Anjou (1636)

The object is to amend the above-mentioned by-law concerning the former city of Anjou's pension plan by introducing a provision relating to the pension committee and article 1.1.6 pertaining to the division and merger of assets and liabilities attributable to the groups of Anjou firefighters, managers and blue collar workers. The RRQ authorized the merger for the part of the assets and liabilities attributable to firefighters and registered the amendments on April 7, 2015, with the exception of paragraphs (2) and (3) of Article 1.1.6. This by-law took effect on December 31, 2007.

The following by-law was adopted at the urban agglomeration council meeting of October 25, 2012:

RCG 08-038-2 Règlement modifiant le Règlement sur le régime complémentaire de retraite des pompiers de l'ancienne Ville de Dollard-des-Ormeaux (RCG 08-038)

The object is to amend the above-mentioned by-law concerning the pension plan of firefighters of the former city of Dollard-des-Ormeaux by introducing article 1.1.5 concerning the merger of assets and liabilities to the absorbing Montreal pension plan as of December 31, 2007. The RRQ authorized the merger and registered the amendments on April 7, 2015.

The following by-law was adopted at the urban agglomeration council meeting of March 27, 2014:

RCG 14-008 Règlement sur le régime de retraite des pompiers de la Ville de Montréal
[By-law concerning the retirement plan of Montréal firefighters]

This by-law contains provisions to harmonize the various firefighter pension plans and took effect on January 1, 2006. Amendments under the by-law were registered by the RRQ April 7, 2015, except for provisions contained in schedules 5, 8 and 14 concerning the Dorval, LaSalle and Pointe-Claire pension plans.

All these by-laws come into force on April 30, 2015, except for the provisions that have not yet been registered by the Régie des rentes du Québec.
