NOTICE is given that the following by-laws were adopted at the regular sitting of Pierrefonds-Roxboro Borough Council held on December 7, 2015.

BY-LAW CA29 0089

By-law concerning the borrowing of \$500,000 for the purchase of equipment, accessories, vehicles, machinery and tools.

BY-LAW CA29 0090

By-law concerning the borrowing of \$800,000 for work related to the municipal buildings, the acquisition of furniture, office and computing equipment.

BORROWING BY-LAW AUTHORIZING THE BORROWING OF \$500,000 FOR THE PURCHASE OF EQUIPMENT, ACCESSORIES, VEHICLES, MACHINERY AND TOOLS FOR THE BOROUGH OF PIERREFONDS-ROXBORO UNDER THE THREE-YEAR PROGRAMME OF CAPITAL EXPENDITURES

At the Borough of Pierrefonds-Roxboro regular council sitting held in the borough hall situated at 13665, boulevard de Pierrefonds, in the said borough, on December 7, 2015, at 7 p.m., in conformity with the Cities and Towns Act (L.R.Q., Chapter C-19), at which were present:

BY VIRTUE OF Section 146.1 of the Charter of Ville de Montréal (L.R.Q., Chapter C-11.4)

BY VIRTUE OF Section 544 of the Cities and Towns Act (L.R.Q., Chapter C-19), particularly sub-section 2 of the second paragraph of said article;

WHEREAS the loan provided for the present by-law is decreed for the execution of works under the borough's three-year programme of capital expenditures.

THE BOROUGH COUNCIL ENACTS THE FOLLOWING:

SECTION 1. A loan of \$500,000 is authorized for financing the acquisition of vehicles and accessories.

SECTION 2. The loan includes professional fees, and other incidental or contingent expenses related to them.

SECTION 3. The total term of the loan and its refinancing will not exceed five (5) years.

SECTION 4. In order to provide for expenses incurred with regard to interests and capital refund of annual terms of the loan incurred by virtue of the present by-law, each year, during the term of the borrowing, a special tax will be levied at a rate sufficient to ensure the reimbursement of the total loan, shared out among all the taxable immovables located on the territory of the borough according to the valuation of these immovables, as appearing annually on the prevailing valuation roll.

This tax will be levied in the way and at the dates fixed for the levying of the general property tax.

SECTION 5. The council allocates any contribution or subsidy which could be deposited for the payment of a part or the total expense decreed by the present by-law to reduce the loan decreed by the present by-law.

SECTION 6. The present by-law comes into force according to law.

BY-LAW AUTHORIZING THE BORROWING OF \$800,000 FOR WORK RELATED TO THE MUNICIPAL BUILDINGS, THE ACQUISITION OF FURNITURE, OFFICE AND COMPUTING EQUIPMENT FOR THE BOROUGH OF PIERREFONDS-ROXBORO, UNDER THE THREE-YEAR PROGRAMME OF CAPITAL EXPENDITURES

BY VIRTUE OF Section 146.1 of the Charter of Ville de Montréal (RLRQ, chapter C-11.4);

BY VIRTUE OF Section 544 of the Cities and Towns Act (L.R.Q., Chapter C-19), particularly sub-section 2 of the second paragraph of said article;

WHEREAS the loan provided for in the present by-law is decreed in order to make capital expenditures regarding an item provided for in the Borough's three-year programme of capital expenditures;

THE BOROUGH COUNCIL ENACTS THE FOLLOWING:

ARTICLE 1. A loan of \$800,000 is authorized for financing work related to the protection of administrative buildings.

ARTICLE 2. The loan includes professional fees, expenses and fees for the study, conception and work inspections and other incidental or contingent expenses related to them.

ARTICLE 3. The total term of the loan and its refinancing will not exceed twenty (20) years.

ARTICLE 4. In order to provide for expenses incurred with regards to interests and capital refund of annual terms of the loan incurred by virtue of the present by-law, each year, during the term of the borrowing, a special tax will be levied at a rate sufficient to ensure the reimbursement of the total loan, shared out among all the taxable immovables located on the territory of the borough according to the valuation of these immovables, as appearing annually on the prevailing valuation roll.

This tax will be levied in the way and at the dates fixed for the levying of the general property tax.

ARTICLE 5. The council allocates any contribution or subsidy, which could be deposited for the payment of a part or the total expense decreed by the present by-law to reduce the loan decreed by the present by-law.

ARTICLE 6. The present by-law comes into force according to law.
