**Notice is given that the following by-law was adopted at the city council meeting of November 23, 2015:**

[By-law authorizing a loan of \$20,155,000 to finance renovation and protection work of immovables]

- 16-003 Règlement autorisant un emprunt de 85 000 000 \$ pour le financement de la mise à niveau de l'éclairage des rues**  
[By-law authorizing a loan of \$85,000,000 to finance the upgrading of street lighting]
- 16-004 Règlement autorisant un emprunt de 20 444 000 \$ afin de financer le programme d'acquisition de mobilier d'éclairage**  
[By-law authorizing a loan of \$20,444,000 to finance the program to purchase lighting furniture]
- 16-005 Règlement autorisant un emprunt de 22 500 000 \$ afin de financer le programme de réaménagement géométrique du réseau routier artériel relevant du conseil municipal**  
[By-law authorizing a loan of \$22,500,000 to finance the geometric redevelopment program for the arterial road system under the authority of city council]
- 16-007 Règlement autorisant un emprunt de 9 920 000 \$ pour le financement des travaux de réfection des infrastructures souterraines et routières et de réaménagement de l'avenue Laurier Ouest, entre l'avenue du Parc et le chemin de la Côte-Sainte-Catherine**  
[By-law authorizing a loan of \$9,920,000 to finance renewal work of underground and road infrastructures and to redevelop Avenue Laurier Ouest, between Avenue du Parc and Chemin de la Côte-Sainte-Catherine]

[By-law authorizing a loan of \$37,500,000 to finance renewal work of underground and road infrastructures and to redevelop Boulevard Laurentien and Rue Lachapelle, between Pont Lachapelle and Rue de Louisbourg]
- 16-009 Règlement autorisant un emprunt de 10 500 000 \$ pour le financement de travaux de réfection routière et de réaménagement de la rue Jarry Est, entre la rue de Rousselot et la rue Saint-Denis**  
[By-law authorizing a loan of \$10,500,000 to finance road renewal and redevelopment work of Rue Jarry Est, between Rue de Rousselot and Rue Saint-Denis]

All these by-laws were approved by the Minister of Municipal Affairs and Land Occupancy on February 25, 2016.
