Notice is given that, on the dates mentioned below, the following by-laws were adopted by the urban agglomeration council:

The amendments under these six by-laws introduce provisions concerning the division of assets and liabilities under the former Montréal-Nord, Saint-Laurent and Communauté urbaine de Montréal pension plans and their merger with Montréal pension plans. By-laws

RCG 08-034 and RCG 09-001 only concern firefighters while the other by-laws concern managers, professionals, blue-collar and white-collar employees.

Retraite Québec authorized the divisions and mergers and proceeded with the registration required under the Supplemental Pension Plans Act (CQLR, c. R-15.1) on April 15, 2015, with respect to by-laws RCG 08-034 and RCG 09-001, and on May 18, 2016, with respect to by-laws RCG 11-004, RCG 13-023, RCG 13-024 and RCG 14-001.

All of these by-laws come into force on August 8, 2016, with retroactive effect, as indicated in the final provisions of each by-law. They may be consulted during regular business hours at the Service du greffe, 275, rue Notre-Dame Est and are also available at www.ville.montreal.qc.ca/reglements
