## **PUBLIC NOTICE UNDER SECTION 192 OF SCHEDULE C TO THE CHARTER OF VILLE DE MONTRÉAL**

### **Third notice**

Notice is hereby given that on the dates mentioned below the city approved the following description of immovables that it intends to acquire under section 192 of schedule C to the Charter of Ville de Montréal:

- Lots 2 003 480, 2 003 491, 2 004 486, 2 004 532, 2 004 656 and 2 004 666 cadastre of Québec, located in the quadrilateral bounded by Rue Rachel Ouest, Boulevard Saint-Laurent, Rue Roy Est and Rue Saint-Urbain, in Le Plateau-Mont-Royal borough (DA166896017 – August 23, 2016)
- Lots 2 003 208, 2 003 225, 2 003 381, 2 003 417, 2 003 440, 2 003 565, 2 003 673, 2 003 922 and 2 004 129 cadastre of Québec, located in the quadrilateral bounded by Avenue Duluth Est, Avenue Laval, Rue Sherbrooke Est and Rue Saint-Dominique, in Le Plateau-Mont-Royal borough (DA166896018 – August 23, 2016)

The owners of the immovables expropriated under that section may claim an indemnity from the city. If no agreement is reached, the indemnity is set by the Tribunal administratif du Québec, at the owners' or at the city's request, and sections 58 to 68 of the Expropriation Act (CQLR, chapter E-24) apply, adapted as required.
