BY-LAW MODIFYING BY-LAW CA29 0010 CONCERNING NUISANCES AND GOOD ORDER TO REPEAL THE DEFINITIONS OF IN-SEASON PARKING AND LOW SEASON PARKING AS WELL AS RECREATIONAL VEHICLES, AND THE ARTICLE 19 CONTROLLING PARKING AND STORAGE OF RECREATIONAL VEHICLES

At the Borough of Pierrefonds-Roxboro regular sitting held in the borough hall situated at 13665, boulevard de Pierrefonds in said borough, on June 5, 2017 at 7 p.m., in conformity with the Cities and Towns Act (L.R.Q., Chapter C-19), at which were present:

all members of the Council and forming a quorum under the chairmanship of the Mayor of the Borough, Mr. Dimitrios (Jim) Beis.

Were also present, Mr. Dominique Jacob, Director of the Borough, and M<sup>c</sup> Suzanne Corbeil, Secretary of the Borough.

THE BOROUGH COUNCIL ENACTS THE FOLLOWING:

By-law CA29 0010 is modified as follows:

ARTICLE 1 The “INTERPRETATIVE PROVISIONS” of section 1 are modified as follows:

- 1° The definition of “Recreational vehicle” is repealed;
- 2° The definition of “In-season parking” is repealed;
- 3° The definition of “Low season parking” is repealed;

ARTICLE 2 Article 19 “Recreational vehicle” is repealed.

ARTICLE 3 The present by-law comes into force in accordance with the Law.
