**Notice is given that the following by-laws were adopted at the city council meeting of May 15, 2017:**

- 17-058 Règlement autorisant un emprunt de 36 000 000 \$ pour financer les travaux prévus au Programme de soutien à la mise aux normes des arénas municipaux**  
[By-law authorizing a loan of \$36,000,000 for work under the support program for upgrading municipal arenas]
- 17-062 Règlement autorisant un emprunt de 400 000 \$ pour financer le remplacement d'équipements mécaniques et spécialisés**  
[By-law authorizing a loan of \$400,000 for the replacement of mechanical and specialized equipment]
- 17-063 Règlement autorisant un emprunt de 20 000 000 \$ pour le financement des travaux de construction et de mise aux normes d'un centre aquatique intérieur, dans l'arrondissement de Rosemont–La Petite-Patrie**  
[By-law authorizing a loan of \$20,000,000 for construction work and the bringing to standards of an interior aquatic centre, in Rosemont–La Petite-Patrie borough]
- 17-065 Règlement autorisant un emprunt de 10 636 000 \$ pour le financement des travaux d'aménagements muséaux dans le cadre du projet de relocalisation du Centre d'Histoire de Montréal au Carré Saint-Laurent**  
[By-law authorizing a loan of \$10,636,000 for museum development work under the project for the relocation of the Centre d'Histoire de Montréal at Carré Saint-Laurent]
- 17-066 Règlement autorisant un emprunt de 21 000 000 \$ afin de financer l'achat de véhicules et de leurs équipements**  
[By-law authorizing a loan of \$21,000,000 for the purchase of vehicles and related equipment]

- 17-069     **Règlement autorisant un emprunt de 1 350 000 \$ pour financer la réalisation d'une œuvre d'art public à être installée sur la jetée Alexandra**  
[By-law authorizing a loan of \$1,350,000 for the creation of a public work of art to be installed on the Alexandra pier]
