

## PUBLIC NOTICE COMING INTO FORCE OF BY-LAWS

**Notice is given that the following by-laws were adopted at the urban agglomeration council meeting of April 27, 2017:**

- RCG 13-020-2 Règlement modifiant le Règlement autorisant un emprunt de 70 400 000 \$ pour le financement des travaux d'aménagement et de mise en valeur du secteur ouest de l'île Sainte-Hélène du parc Jean-Drapeau, pilotés par la Société du Parc Jean-Drapeau dans le cadre du 375<sup>e</sup> de la Ville de Montréal (RCG 13-020)**  
[By-law amending the By-law authorizing a loan of \$70,400,000 for development and enhancement work in the western sector of Île Sainte-Hélène, in Parc Jean-Drapeau, piloted by the Société du parc Jean-Drapeau as part of the city's 375<sup>th</sup> anniversary (RCG 13-020)]  
The object is to increase the amount of the loan by \$3,000,000.
- RCG 15-012-1 Règlement modifiant le Règlement d'emprunt portant le numéro RCG 15-012 autorisant un emprunt de 44 451 000 \$ afin de financer deux centres de tri des matières recyclables**  
[By-law amending the by-law bearing number RCG 15-012 authorizing a loan of \$44,451,000 to finance the construction of two recyclable material sorting centres]  
The object is to increase the amount of the loan by \$9,036,000 and to specify that the loan will be used for only one sorting centre instead of two.
- RCG 16-030-1 Règlement modifiant le Règlement autorisant un emprunt de 8 187 000 \$ afin de financer les travaux de réhabilitation des réservoirs et des stations de pompage (RCG 16-030)**  
[By-law amending the By-law authorizing a loan of \$8,187,000 for the rehabilitation of the reservoirs and pumping stations (RCG 16-030)]  
The object is to increase the amount of the loan by \$4,000,000.
