## PUBLIC NOTICE UNDER SECTION 192 OF SCHEDULE C TO THE CHARTER OF VILLE DE MONTRÉAL

### Third notice

Notice is hereby given that on the dates mentioned below the city approved the following description of immovables that are either streets, lanes, thoroughfares or places that it intends to acquire under section 192 of schedule C to the Charter of Ville de Montréal:

- part of lot 1 744 881 (125 m<sup>2</sup>) and part of lot 1 744 882 (119.3 m<sup>2</sup>), located southeast of Rue Sauvé Est, between Avenue Vianney and Rue Sackville, part of lot 1 744 858 (127.5 m<sup>2</sup>) and part of lot 1 744 859 (117.2 m<sup>2</sup>), located northwest of Rue Fleury Est, between Avenue Vianney and Rue Sackville, part of lot 1 744 871 (200.3 m<sup>2</sup>), located northwest of Rue Sauvé Est, between Rue J.-J.-Gagnier and Avenue Larose, as well as part of lot 1 744 877 (200.3 m<sup>2</sup>) located southeast of Rue Sauvé Est, between Rue J.-J.-Gagnier and Avenue Larose; all these parts of lots being of the cadastre of Québec and forming lanes in the Ahuntsic-Cartierville borough (DA172551014 – August 4, 2017)
- lots 3 460 161 and 3 726 044, cadastre of Québec, located in the quadrilateral made up of Rue Boyer, Rue Villeray, Rue Rosaire and Avenue De Chateaubriand, in Villeray–Saint-Michel–Parc-Extension borough (DA176896085 – August 28, 2017)
- lots 3 460 159, 3 460 178, 3 460 180, 3 460 195 and 3 726 052, cadastre of Québec, located in the quadrilateral made up of Rue Saint-Hubert, Rue Faillon Est, Rue Saint-Gérard and Rue Rosaire, in Villeray–Saint-Michel–Parc-Extension borough (DA176896086 – August 29, 2017)
- lots 1 567 943 and 1 567 944, cadastre of Québec, forming part of Avenue Lalonde, located between Rue de la Visitation and Rue Panet, in Ville-Marie borough (DA172551012 – August 29, 2017)
- lots 3 460 212, 3 460 227, 3 460 236, 3 460 237 and 3 726 053, cadastre of Québec, located in the quadrilateral made up of Rue Jean-Talon Est, Rue Lajeunesse, Rue Faillon Est and Avenue De Chateaubriand, in Villeray–Saint-Michel–Parc-Extension borough (DA176896087 – August 30, 2017)
- lots 3 460 197, 3 460 230, 3 460 243, 3 726 014, 3 726 015, 3 726 068 and 3 726 071, cadastre of Québec, located in the quadrilateral made up of Rue Saint-André, Rue Jean-Talon Est, Rue Villeray and Avenue De Chateaubriand, in Villeray–Saint-Michel–Parc-Extension borough (DA176896088 – August 30, 2017)

The owners of the immovables expropriated under that section may claim an indemnity from the city. If no agreement is reached, the indemnity is set by the Tribunal administratif du Québec, at the owners' or at the city's request, and sections 58 to 68 of the Expropriation Act (CQLR, chapter E-24) apply, adapted as required.
