



COMING INTO FORCE OF BY-LAWS

Notice is given that the following by-law was adopted at the city council meeting of January 22, 2018:

02-039-7 Règlement modifiant le Règlement sur le traitement des membres du conseil (02-039)

[By-law amending the By-law concerning the remuneration of council members (02-039)]

This by-law maintains, for Montréal's elected officials, the maximum remunerations which were applicable on December 31, 2017, under legislative provisions repealed on January 1, 2018. In addition, it provides for the reduction of remuneration paid by the city in order to avoid exceeding those limits. This by-law takes effect retroactively on January 1, 2018.

[By-law concerning the tax burden (fiscal 2018)]

The object is to specify the portion of the tax burden increase that does not result from the constitution of the city as to the harmonization of tax burdens in the various sectors where the tax burden borne by the aggregate of the units of assessment of a category of immovables for fiscal 2018 is higher than the one borne for fiscal 2017.

10-007-2 Règlement modifiant le Règlement relatif au taux du droit de mutation applicable aux transferts dont la base d'imposition excède 500 000 \$ (10-007)

[By-law amending the By-law concerning the rate of transfer duties applicable to transfers whose basis of imposition exceeds \$500,000 (10-007)]

The object consists of amending article 2 of the by-law to harmonize it with the new indexed value thresholds used for the calculation of transfer duties applicable to transfers whose basis of imposition exceeds \$500,000. This by-law takes effect on February 1, 2018.

14-010-1 Règlement modifiant le Règlement créant la réserve financière destinée à financer des dépenses en immobilisations (14-010)

[By-law amending the By-law creating the financial reserve covering certain capital works expenditures (14-010)]

The object of this by-law is to increase the amount of the financial reserve to \$550M.
