#### BY-LAW MODIFYING BY-LAW CA29 0061 CONCERNING THE USE OF PARKS IN ORDER TO ADD SMOKING PROHIBITION IN PARKS AS WELL AS THE DEFINITION OF THE TERM "SMOKING"

At the Borough of Pierrefonds-Roxboro regular sitting held in the council room located at 13665, boulevard de Pierrefonds in said borough, on May 7, 2018 at 7 p.m., in conformity with the Cities and Towns Act (L.R.Q., Chapter C-19), at which were present:

Mayor of the Borough

Councillors

Catherine Clément-Talbot Louise Leroux Benoit Langevin Yves Gignac

All members of the Council and forming a quorum under the chairmanship of the Mayor of the Borough, Mr. Dimitrios (Jim) Beis.

The Director of the Borough, Mr. Dominique Jacob and the Secretary of the Borough, M<sup>e</sup> Suzanne Corbeil, were also present.

BY VIRTUE OF the Tobacco Control Act (RLRQ, c. L-6.2);

BY VIRTUE OF Sections 7 and 59 of the Municipal Powers Act (R.S.Q., chapter C-47.1)

BY VIRTUE OF Sections 136.1 and 141 of the Charter of Ville de Montréal (R.S.Q., Chapter C-11.4);

THE BOROUGH COUNCIL ENACTS THE FOLLOWING:

By-law CA29 0061 is amended as follows:

**ARTICLE 1.** By the addition of the following definition in the section "DEFINITIONS":

"SMOKING" also includes the use of an electronic cigarette or of any other device of this type.

**ARTICLE 2.** By the addition at article 15 of the following paragraph:

k) to smoke

**ARTICLE 3.** By the addition, after article 17, of the following article 17.1:

- 17.1 Despite article 16, anyone who contravenes paragraph k of article 15 commits an offence and is punishable by a fine of \$250 to \$750 for a first offence and in the event of a repeated infringement, of a fine of \$500 to \$1 500.
  - **ARTICLE 4.** The present by-law comes into force in accordance with the Law.
