## **PUBLIC NOTICE UNDER SECTION 192 OF SCHEDULE C TO THE CHARTER OF VILLE DE MONTRÉAL, METROPOLIS OF QUÉBEC**

### **Third notice**

Notice is hereby given that on the dates mentioned below the city approved the following description of immovables that are either streets, lanes, thoroughfares or places that it intends to acquire under section 192 of schedule C to the Charter of Ville de Montréal, metropolis of Québec:

- Lot 1 362 226, cadastre of Québec, located northwest of Rue de Marseille, between Rue Louis-Veuillot and Rue Bossuet, in Mercier–Hochelaga-Maisonneuve borough (DA186896014 – May 3, 2018)
- Two parts of lot 3 793 445, cadastre of Québec, having respective areas of 544.2 m<sup>2</sup> and 280.2 m<sup>2</sup>, located in the quadrilateral made up of Rue Chambord, Rue Beaubien Est, Rue De Normanville and Rue Saint-Zotique Est, in Rosemont–La Petite-Patrie borough (DA186896012 – May 4, 2018)
- Lots 1 381 448 and 1 381 452, cadastre of Québec, located southeast of Rue Hall, between Rue de Dublin and Rue Fortune, in Le Sud-Ouest borough (DA186896015 – May 10, 2018)
- Lot 2 537 321, cadastre of Québec, located northwest of Rue Raudot, between Rue Dumas and Rue D’Aragon, in Le Sud-Ouest borough (DA186896016 – May 15, 2018)
- Lot 1 591 416, cadastre of Québec, located in the quadrilateral made up of Rue Lafond, Rue Masson, Avenue Laurier Est and 13<sup>e</sup> Avenue, in Rosemont–La Petite-Patrie borough (DA186896017 – May 15, 2018)
- Part of lot 1 870 169, cadastre of Québec, having an area of 141.7 m<sup>2</sup>, located northwest of Rue Jean-Talon Ouest, between Rue Alexandra and Rue Marconi, in Villeray–Saint-Michel–Parc-Extension borough (DA186896005 – May 16, 2018)

The owners of the immovables expropriated under that section may claim an indemnity from the city. If no agreement is reached, the indemnity is set by the Tribunal administratif du Québec, at the owners’ or at the city’s request, and sections 58 to 68 of the Expropriation Act (CQLR, chapter E-24) apply, adapted as required.
