



## COMING INTO FORCE OF BY-LAWS

Notice is given that the following by-laws were adopted at the city council meeting of September 17, 2018:

- 18-002-5**      **Règlement modifiant le Règlement sur les tarifs (exercice financier 2018) (18-002)**  
[By-law amending the By-law concerning fees (fiscal 2018) (18-002)]  
This by-law replaces paragraph (12) of article 109 concerning the schedule for paid parking on certain streets of the Verdun borough.
- 18-051**      **Règlement modifiant le règlement 2302 adopté par l'ancienne ville de Lachine décrétant la fermeture de la ruelle portant le numéro de cadastre P. 293-576 et le règlement 2341 décrétant la fermeture de la ruelle est-ouest, portant le numéro de cadastre 293-564, sise entre les 16<sup>e</sup> et 17<sup>e</sup> Avenues, au nord de la rue St-Antoine, dans l'arrondissement de Lachine, aux fins de transfert aux propriétaires riverains**  
[By-law amending the By-law 2302 adopted by the former Ville de Lachine, enacting the closure of the lane bearing the cadastral number P. 293-576 and By-law 2341 enacting the closure of the east-west lane, bearing the cadastral number 293-564, located between 16<sup>e</sup> Avenue and 17<sup>e</sup> Avenue, north of Rue St-Antoine, in Lachine borough, for the purposes of transfer to bordering owners]
- 18-052**      **Règlement sur la fermeture d'une ruelle située au nord-ouest de la rue Cherrier, entre la 42<sup>e</sup> Avenue et la 43<sup>e</sup> Avenue, dans l'arrondissement de Rivière-des-Prairies–Pointe-aux-Trembles, aux fins de transfert aux propriétaires riverains**  
[By-law to close a lane located northwest of Rue Cherrier, between 42<sup>e</sup> Avenue and 43<sup>e</sup> Avenue, in Rivière-des-Prairies–Pointe-aux-Trembles borough, for the purposes of transfer to bordering owners]
- 02-003-4**      **Règlement modifiant le Règlement identifiant les réseaux de voirie artérielle et locale (02-003)**  
[By-law amending the By-law concerning the arterial and local road systems (02-003)]  
This by-law replaces schedule 1 "Administrative arterial system, Ville de Montréal, 2017" to take into account the evolution of the road system since the last modification in 2017.
- 02-136-10**      **Règlement modifiant le Règlement sur le Conseil du patrimoine de Montréal (02-136)**  
[By-law amending the By-law concerning the Conseil du Patrimoine de Montréal (02-136)]  
The amendments allow the appointment of 2 to 5 substitute members.
