**BY VIRTUE OF** the Quebec's Cities and Towns Act, Section 345.1

THE BOROUGH COUNCIL ENACTS THE FOLLOWING:

ARTICLE 1. The public notices subject to the provisions of the present by-law are those required by virtue of any act or by-law applicable to the Borough of Pierrefonds-Roxboro of the Ville de Montréal.

ARTICLE 2. The public notices referred to in article 1 will be, from the entry into force of the present by-law, published only on the Ville de Montréal's website on the Borough of Pierrefonds-Roxboro's page.

ARTICLE 3. Notwithstanding article 2, any public call for tenders for the granting of a contract set out in articles 573 and following of the Quebec's Cities and Towns Act must be published according to the rules prescribed by said article.

ARTICLE 4. This by-law comes into force in accordance with the Law.

BY-LAW REGARDING THE LIBRARIES OF THE BOROUGH OF  
PIERREFONDS-ROXBORO

At the Borough of Pierrefonds-Roxboro regular sitting held at the East Community Center located at 9665, boulevard Gouin Ouest in Pierrefonds, on October 2, 2018 at 7 p.m., in conformity with the Cities and Towns Act (L.R.Q., Chapter C-19), at which were present:

All members of the Council and forming a quorum under the chairmanship of the Mayor of the Borough, Mr. Dimitrios (Jim) Beis.

The Director of the Borough, Mr. Dominique Jacob and the Secretary of the Borough, M<sup>e</sup> Suzanne Corbeil, were also present.

WHEREAS articles 4 and 7 of the Municipal Powers Act, (L.R.Q., chapter C-47.1);

WHEREAS articles 130 and 141 of the Charter of Ville de Montréal, (L.R.Q., chapter C-11.4);

THE BOROUGH COUNCIL ENACTS THE FOLLOWING:

**CHAPTER I**  
GENERAL PROVISIONS

1. The present by-law sets out the rules that are to be followed by the library users;

**CHAPTER II**  
DEFINITION

2. In the present by-law, unless the context suggests a different meaning, the following expressions and words have the following meaning:

“library”: designates the public libraries located on the Pierrefonds-Roxboro Borough territory;

“document”: any book, media or other platform containing information that the library provides users with;

“network” of the Montréal libraries: refers to the public libraries regrouping located on the Ville de Montréal territory;

“person in charge”: the division head of the libraries, its representative or an employee of the library;

“user”: anyone who uses the Pierrefonds-Roxboro Borough library services or any of the libraries of the Montreal libraries network.

### **CHAPTER III**

#### **CODE OF CONDUCT**

#### **3. The users shall not:**

- 1° talk loudly, scream, sing, run, push or heckle;
- 2° use coarse, offensive, obscene or abusive language towards the employees or the other users;
- 3° have a rude, offensive or abusive behavior towards the employees or the other users;
- 4° sleep;
- 5° leave the cellular phones and pagers ringtones on;
- 6° use any equipment audible by the other users;
- 7° bring animals in the building, with the exception of those who assist people with disabilities;
- 8° proceed in all forms of solicitation, commercial activity, petition and posting without prior authorization from the person in charge;
- 9° remove shoes or be barechested and/or barefoot;
- 10° be under the influence of alcohol or drugs or consume it;
- 11° photograph or record - video or audio – inside the library without prior authorization from the person in charge;
- 12° consume food or drinks in another area than those specifically intended for that purpose;
- 13° smoke;
- 14° place feet on furniture or equipment, in particular on tables, chairs, armchairs or consultation stations;
- 15° highlight, underline, annotate, cut, tear, fold, draw or damage in any other way the documents;
- 16° bring and consult the documents in another area than those specifically intended for that purpose, namely in the washrooms;
- 17° modify the softwares or computers configuration;

18° use sports equipment inside the library, such as skateboards, in-line skating, scootering, balloons, balls, bicycles or any other similar equipment;

19° leave children under the age of seven unsupervised by an assisting responsible person;

20° remain on the library premises outside opening hours;

**4.** A user who contravene to one of the prohibitions set out in article 3 of the present by-law loses its access and borrowing privileges in all the public libraries of the Borough of Pierrefonds-Roxboro, for a period of:

1° one day for a first offence;

2° one week for a second offence;

3° one month for a third offence.

**5.** No user shall:

1° cause damages to premises, equipment or furniture;

2° verbally abuse the other users or the employees of the library;

3° exert any act of harassment.

**6.** A user who contravene to one of the prohibitions set out in article 5 of the present by-law loses its access and borrowing privileges in all the public libraries of the Borough of Pierrefonds-Roxboro, for a period of:

1° one month for a first offence;

2° three months for a second offence;

3° one year for a third offence.

**7.** No user shall:

1° consult, download or distribute material with hateful, discriminatory or pornographic content;

2° physically assault other users or the employees;

3° have an indecent behaviour towards the employees or the other users;

4° steal or try to steal property belonging to the Ville de Montréal.

**8.** A user who contravene to one of the prohibitions set out in article 7 of the present by-law loses its access and borrowing privileges in all the public libraries of the Borough of Pierrefonds-Roxboro, for a period of one year.

**CHAPTRE IV :**  
**APPLICATION**

**9.** A user who contravene to one of the prohibitions set out in articles 3, 5 or 7 of the present by-law is subject to immediate expulsion from the library premises;

**10.** The individual who loses its access or borrowing privileges, for a given period, in one of the libraries of the Montreal network cannot have access to the libraries located within the territory of the Pierrefonds-Roxboro Borough for the same period.

**CHAPTRE IV :**  
**PENAL PROVISIONS**

**11.** Anyone who contravene to a provision of the present by-law other than those referred to in paragraph 2 of article 7 or in paragraph 4 of article 7 commits an offence and is liable to:

- 1° for a first offence, of a fine of \$350 to \$1000;
- 2° for a second offence, of a fine of \$700 \$ to \$2000;
- 3° for any additional offence, of a fine of \$2000 to \$3000.

**12.** The present by-law comes into force according to the Law.
