### ***Impacts of the Royalmount project***

The *Commission sur le développement économique et urbain et l'habitation* invites citizens to take part in a public consultation meeting concerning the impacts of the Royalmount project, a large shopping centre including tourist accommodation and entertainment infrastructures, located at the intersection of Autoroute 15 and Autoroute 40, in the industrial sector of the City of Mount Royal. In addition to these components, the developer plans to add a residential section, which would require a modification to the Montréal urban agglomeration land use and development plan.

This consultation will allow the committee to present the results of project impact analysis, namely regarding traffic, the local and urban agglomeration commercial structure, the municipal fiscal benefits and the urban integration of the project. During the first public meeting, participants will be invited to ask questions, namely regarding the tabling of a brief or an opinion to the committee, as of December 19.
