



COMING INTO FORCE OF BY-LAWS

Notice is given that the following by-laws were adopted at the city council meeting of November 19, 2018:

- 18-060** **Règlement modifiant le Règlement 1654 adopté par l'ancienne Ville de Montréal-Nord et abrogeant le Règlement 1653 à l'égard seulement de la partie résiduelle de la ruelle située au nord-ouest de la rue Monselet, entre l'avenue des Récollets et l'avenue Gariépy, dans l'arrondissement de Montréal-Nord, aux fins de transfert aux propriétaires riverains**
[By-law amending By-law 1654 adopted by the former Ville de Montréal-Nord and repealing By-law 1653 with respect to the residual part of the lane located northwest of Rue Monselet, between Avenue des Récollets and Avenue Gariépy, in Montréal-Nord borough, for the purposes of transfer to bordering owners]
- 18-063** **Règlement abrogeant le règlement 17-090 et décrétant la fermeture d'une ruelle située au sud-est de la rue Forsyth, entre la 17^e Avenue et la 18^e Avenue, dans l'arrondissement de Rivière-des-Prairies–Pointe-aux-Trembles, aux fins de transfert aux propriétaires riverains**
[By-law repealing by-law 17-090 and enacting the closure of a lane located southeast of Rue Forsyth, between 17^e Avenue and 18^e Avenue, in Rivière-des-Prairies–Pointe-aux-Trembles borough, for the purposes of transfer to bordering owners]
- 18-066** **Règlement déterminant les secteurs de planification urbaine sur lesquels le droit de préemption peut être exercé et les fins pour lesquelles des immeubles peuvent y être ainsi acquis**
[By-law determining the urban planning sectors where the city's pre-emptive right may be exercised and the purposes for which the immovables may thus be acquired]
- 03-009-8** **Règlement modifiant le Règlement intérieur du conseil sur la délégation de pouvoirs au comité exécutif (03-009)**
[By-law amending the By-law concerning the delegation of city council powers to the executive committee (03-009)]
The object of this by-law is to delegate to the executive committee the power to exercise a pre-emptive right, to acquire an immovable for which a pre-emptive right has been registered, as well as to decide not the exercise such right.
- 14-012-1** **Règlement modifiant le Règlement sur les services (14-012)**
[By-law amending the By-law concerning departments (14-012)]
The object of this by-law is to create, transfer or abolish certain business units in order to reflect organizational changes. It takes effect on January 1, 2019.
