



## OPENING OF A REGISTER

### TO QUALIFIED VOTERS ENTITLED TO HAVE THEIR NAMES ENTERED ON THE REFERENDUM LIST FOR THE ENTIRE CÔTE-DES-NEIGES—NOTRE-DAME-DE-GRÂCE BOROUGH

**PUBLIC NOTICE** is hereby given that:

1. The Côte-des-Neiges—Notre-Dame-de-Grâce Borough Council, at its meeting held on April 1, 2019, adopted the following by-law :
  - ***By-law repealing the By-law RCA15 17261 authorizing a loan of \$600,000 to acquire vehicles and associated equipment (RCA19 17316).***
2. The loan shall be a burden on all ratepayers of the Côte-des-Neiges—Notre-Dame-de-Grâce borough.
3. Qualified voters entitled to be entered on the referendum list of the Côte-des-Neiges—Notre-Dame-de-Grâce borough may request that by-law RCA19 17316 be submitted to a referendum poll by entering their name, address and capacity, together with their signature, in the register open for this purpose for this by-law.
4. The conditions that must be met to be considered a qualified voter entitled to be entered on the referendum list of the Côte-des-Neiges—Notre-Dame-de-Grâce borough may be obtained from the Borough Office, located at 5160 Décarie, Suite 600, during normal office hours, i.e. from Monday to Friday, 8:30 a.m. to noon and 1 to 4:30 p.m.
5. The register will be open from 9 a.m. to 7 p.m., from Monday, April 8, 2019 to Friday, April 12, 2019, at the Côte-des-Neiges—Notre-Dame-de-Grâce Accès Montréal office, located at 5160, boulevard Décarie, ground floor.
6. The number of signatures needed to require that a referendum poll be held is 9 966. If this number is not reached, the by-law will be deemed approved by qualified voters.
7. To sign the register, qualified voters entitled to have their names entered on the referendum list must establish their identity by presenting their health-insurance card, driver's licence or Canadian passport and a proof of residency or ownership, as applicable.
8. The results of the registration process will be announced in the room where the registration is held, on Friday, April 12, 2019, at 7 p.m. or as soon as they are available.
9. The by-law may be consulted at the Accès Montréal Office, at 5160, boulevard Décarie, ground floor, from Monday to Friday between 8:30 a.m. and 5 p.m.
