



COMING INTO FORCE OF BY-LAWS

Notice is given that the following by-laws were adopted at the city council meeting of April 15, 2019:

- 03-009-10** **Règlement modifiant le Règlement intérieur du conseil sur la délégation de pouvoirs au comité exécutif (03-009)**
[By-law amending the By-law concerning the delegation of city council powers to the executive committee (03-009)]
This by-law delegates to the executive committee the powers devolved to the chief executive officer concerning the tendering and awarding processes within the meaning of the Act to facilitate oversight of public bodies' contracts and to establish the Autorité des marchés publics.
- 19-025** **Règlement sur les subventions aux sociétés de développement commercial financées par le Fonds de dynamisation des rues commerciales**
[By-law concerning subsidies to commercial development associations funded by the *Fonds de dynamisation des rues commerciales*]
The object of this by-law is to establish the amount of the nonrecurring subsidies awarded to 4 commercial development associations of the Plateau-Mont-Royal borough.
- 19-026** **Règlement relatif aux services de véhicules non immatriculés en libre-service sans ancrage**
- 18-070-1** **Règlement modifiant le Règlement sur les tarifs (exercice financier 2019) (18-070)**
[By-law amending the By-law concerning fees (fiscal 2019) (18-070)]
This by-law adds the fees concerning operating permits for dockless self-serve unregistered vehicles.
- 15-063-3** **Règlement modifiant le Règlement sur la subvention relative au traitement des frênes situés sur des propriétés privées (15-063)**
[By-law amending the By-law concerning the subsidy for the treatment of ash trees located on private property (15-063)]
The subsidy program is amended to allow private owners to have their ash trees treated by city contractors without charge.
- 18-070-2** **Règlement modifiant le Règlement sur les tarifs (exercice financier 2019) (18-070)**
[By-law amending the By-law concerning fees (fiscal 2019) (18-070)]
The object of this by-law is to remove the 90-day subscription from the BIXI service fee schedule.

18-020-1 Règlement modifiant le Règlement fixant le montant des amendes à l'égard des infractions en matière de stationnement ou d'immobilisation des véhicules (18-020)

[By-law amending the By-law concerning vehicle parking or immobilization fines (18-020)]

This by-law increases the amount of fines related to general offences and to the parking or immobilization of a vehicle in a no-stopping zone, in a reserved lane.

The by-laws come into force April 23, 2019, and may be consulted during regular business hours at the Service du greffe, 275, rue Notre-Dame Est (155, rue Notre-Dame Est as of April 29, 2019). They are also available at www.ville.montreal.qc.ca/reglements.
