BY-LAW CA29 0116 REGARDING THE REMUNERATION OF THE PIERREFONDS-ROXBORO COUNCIL MEMBERS

NOTICE is hereby given that at its regular sitting that will be held on Monday, December 2, 2019 at 7 p.m., in the council room located at 13665, boulevard de Pierrefonds, the Borough Council will adopt by-law number CA29 0116 entitled "By-law regarding the remuneration of the Pierrefonds-Roxboro council members".

This by-law has the objective to:

- set the basic annual remuneration of the Borough council members at \$31,953;
- set an additional annual remuneration of the president of the Urban Planning Advisory Committee at \$3,688;
- establish an additional remuneration calculated according to the income tax payable on this remuneration and on the allowance provided for in the Act respecting the remuneration of elected municipal officers.

This remuneration will be indexed on each fiscal year from the one beginning after its entry into force, on the basis of a percentage corresponding to the rate of increase in the consumer price index for Québec established by Statistics Canada for the previous year.

This by-law will have a retroactive effect as of January 1, 2019.

BY-LAW REGARDING THE REMUNERATION OF COUNCIL MEMBERS OF THE BOROUGH OF PIERREFONDS-ROXBORO

At the Borough of Pierrefonds-Roxboro regular council sitting held at the Borough Hall located at 13665, boulevard de Pierrefonds, in the said borough, on November 4, 2019 at 7 p.m., in conformity with the Cities and Towns Act (R.S.Q., Chapter C-19), at which were present:

all members of the Council and forming a quorum under the chairmanship of the Mayor of the Borough, Mr. Dimitrios (Jim) Beis.

Mr. Dominique Jacob, Director of the Borough and M^e Suzanne Corbeil, Secretary of the Borough were also present.

BY VIRTUE of Section 2 of the Act respecting the remuneration of elected municipal officers (R.S.Q., chapter T-11.001);

BY VIRTUE of Section 43 of the Charter of Ville de Montréal (R.S.Q., Chapter C-11.4);

THE BOROUGH COUNCIL ENACTS THE FOLLOWING:

ARTICLE 1

The basic annual remuneration of the Borough councillors is set at \$31,953.

ARTICLE 2

The additional annual remuneration of the president of the Urban Planning Advisory Committee is set at \$3,688.

ARTICLE 3

All Borough councillors receive an additional remuneration corresponding to the amount of any income tax that would be payable by the member for the year on the amount of this additional remuneration and the allowance to which he is entitled according to article 19 of the Act respecting the remuneration of elected municipal officers (R.S.Q., chapter T-11.001), if it wasn't taken into account in the calculation of his taxable income of the remunerations which are payable for all his tasks at the City, a City delegated organization or a supra-municipal organization.

ARTICLE 4

The remunerations set at articles 1 and 2 of the present by-law are indexed with an increase if appropriate, for each fiscal year as of the one that begins after its entry into force.

The indexation consists in the increase, for each City fiscal year, of a percentage corresponding to the rate increase of the Consumer Price Index for Quebec established by Statistics Canada for the previous year.

ARTICLE 5

The City Executive Committee determines the method of payment for the remunerations provided for in this by-law as well as the expense allowance provided in the Act respecting the remuneration of elected municipal officers.

ARTICLE 6

This by-law has been effective since January 1, 2019 and replaces, towards the council members of the Borough of Pierrefonds-Roxboro, any other provision regarding the same subject.

ARTICLE 7

The present by-law comes into force according to Law.
