



## COMING INTO FORCE OF BY-LAWS

Notice is given that the following by-laws were adopted at the city council meeting of December 16, 2019:

- 19-054**      **Règlement relatif au fardeau fiscal (exercice financier 2020)**  
[By-law concerning the tax burden (fiscal 2020)]  
The object is to specify the portion of the tax burden increase that does not result from the constitution of the city as to the harmonization of tax burdens in the various sectors where the tax burden borne by the aggregate of the units of assessment of a category of immovables for fiscal 2020 is higher than the one borne for fiscal 2019.
- 19-055**      **Règlement sur les taxes (exercice financier 2020)**  
[By-law concerning taxes (fiscal 2020)]
- 19-056**      **Règlement concernant la taxe foncière sur les parcs de stationnement (exercice financier 2020)**  
[By-law concerning property taxes on parking lots (fiscal 2020)]
- 10-007-4**    **Règlement modifiant le Règlement relatif au taux du droit de mutation applicable aux transferts dont la base d'imposition excède 500 000 \$ (10-007)**  
[By-law amending the By-law concerning transfer duties applicable to transfers whose basis of imposition exceeds \$500,000 (10-007)]  
The purpose of the amendment is to index the parts of the basis of imposition that exceed \$500,000 and to add a specific rate for the part that exceeds \$2,000,000. This by-law takes effect on January 1, 2020.
- 19-057**      **Règlement sur les tarifs (exercice financier 2020)**  
[By-law concerning fees (fiscal 2020)]  
This by-law takes effect on January 1, 2020 and replaces by-law 18-070 on that date.
- 08-056-6**    **Règlement modifiant le Règlement intérieur de la Ville sur la délégation du conseil de la Ville aux conseils d'arrondissement de certains pouvoirs relatifs à des parcs et équipements ainsi qu'à l'aménagement et au réaménagement du domaine public dans le secteur du centre-ville (08-056)**  
[By-law amending the By-law concerning the delegation by city council to borough councils of certain powers relating to parks and facilities as well as the development and redevelopment of public property in the downtown area (08-056)]  
The purpose of the amendment is to delegate routine maintenance responsibility for Esplanade Clark to Ville-Marie borough.

**19-022-1      Règlement modifiant le Règlement sur le programme de subventions  
relatif à la réhabilitation des terrains contaminés (19-022)**

[By-law amending the By-law concerning the subsidy program for the rehabilitation of contaminated land (19-022)]

The amendments are namely intended to reduce requirements related to certification of site assessments and reports, limit the combination of public financial assistance, increase the possible assistance for projects located in former residual materials disposal sites and establish the maximum eligible cost for professional services.

**19-058      Règlement abrogeant le Règlement sur la prévention des troubles de  
la paix, de la sécurité et de l'ordre publics, et sur l'utilisation du  
domaine public (R.R.V.M., c. P-6)**

[By-law repealing the By-law concerning the prevention of breaches of the peace, public order and safety, and the use of public property (R.B.C.M., c. P-6)]
