**BY-LAW CA29 0116-1 MODIFYING BY-LAW REGARDING
THE REMUNERATION OF COUNCIL MEMBERS OF THE BOROUGH OF
PIERREFONDS-ROXBORO**

NOTICE is hereby given that at its regular sitting that will be held on Monday, **April 6, 2020** at 7 p.m., at the **Gerry Robertson Community Center** located at 9665, boulevard Gouin Ouest, the Borough Council will adopt by-law number CA29 0116-1 modifying by-law number CA29 0116 regarding the remuneration of council members of the Borough of Pierrefonds-Roxboro in order to stipulate that the basic annual remuneration of the Borough councilors be established at eighty percent (80 %) of the basic annual remuneration of the city councilors.

This by-law has the objective to raise the basic annual remuneration of the Borough councilors from \$31,953 to eighty percent (80 %) of the basic annual remuneration of the City councilors, which is currently of \$55,306.

It represents an annual increase of \$12,292.

This by-law will have a retroactive effect as of January 1, 2020.

BY-LAW MODIFYING BY-LAW REGARDING THE REMUNERATION OF COUNCIL MEMBERS OF THE BOROUGH OF PIERREFONDS-ROXBORO IN ORDER TO STIPULATE THAT THE BASIC ANNUAL REMUNERATION OF THE BOROUGH COUNCILLORS BE ESTABLISHED AT EIGHTY PERCENT (80 %) OF THE BASIC ANNUAL REMUNERATION OF THE CITY COUNCILLORS

At the Borough of Pierrefonds-Roxboro regular council sitting held at the Borough Hall located at 13665, boulevard de Pierrefonds, in the said borough, on March 9, 2020 at 7 p.m., in conformity with the Cities and Towns Act (R.S.Q., Chapter C-19), at which were present:

BY VIRTUE of Section 2 of the Act respecting the remuneration of elected municipal officers (R.S.Q., chapter T-11.001);

BY VIRTUE of Section 43 of the Charter of Ville de Montréal (R.S.Q., Chapter C-11.4);

THE BOROUGH COUNCIL ENACTS THE FOLLOWING:

ARTICLE 1

Article 1 of by-law CA29 0116 on the remuneration of the Pierrefonds-Roxboro Borough councillors is replaced as follows:

“The basic annual remuneration of the Borough councillors is established at eighty percent (80%) of the basic annual remuneration of the City councillors.”

ARTICLE 2

The present by-law has been in force since January 1, 2020.

ARTICLE 3

The present by-law comes into force according to Law.
