



## COMING INTO FORCE OF BY-LAWS

Notice is given that the following by-laws were adopted at the city council meeting of May 25, 2020:

- 20-022**      **Règlement autorisant l'agrandissement et l'occupation d'une résidence à des fins d'hébergement pour personnes ayant besoin d'aide et d'assistance sur les lots 1 879 188 et 1 881 998 du cadastre du Québec**  
[By-law authorizing the expansion and occupancy of a residence located on lots 1 879 188 and 1 881 998, cadastre of Québec, for housing purposes, for persons in need of help and assistance]
- 19-055-1**      **Règlement modifiant le Règlement sur les taxes (exercice financier 2020) (19-055)**  
[By-law amending the By-law concerning taxes (Fiscal 2020) (19-055)]  
The object of the amendment is to extend the deadline for the 2nd instalment payment of property taxes from June 1 to July 2, 2020.
- 03-108-4**      **Règlement modifiant le Règlement intérieur du conseil de la Ville portant délégation aux conseils d'arrondissement de certains pouvoirs relatifs aux sociétés de développement commercial (03-108)**  
[By-law amending the By-law concerning the delegation to borough councils of certain powers relating to commercial development associations (03-108)]  
The amendments create an exception to the general delegation of powers under paragraph (5) of article 1 allowing city council to adopt a by-law amending the deadline for the 2nd instalment payment of the assessment for 2020, where the amount due is over \$300.
- 20-024**      **Règlement modifiant divers règlements portant sur l'approbation de budgets de fonctionnement de sociétés de développement commercial pour la période du 1<sup>er</sup> janvier au 31 décembre 2020 et imposant des cotisations pour cette période**  
[By-law amending various by-laws concerning the approval of operating budgets of commercial development associations for the period of January 1 to December 31, 2020, and imposing assessments for that period]  
The object of the amendment is to postpone by 3 months the deadline for the second instalment payment of the assessment for 2020 set in borough by-laws.

**20-025      Règlement sur les subventions aux sociétés de développement commercial financées par le Fonds de dynamisation des rues commerciales**

[By-law concerning subsidies to commercial development associations funded by the Fonds de dynamisation des rues commerciales]

The object of this by-law is to establish the amount of the nonrecurring subsidies awarded to 4 commercial development associations of Le Plateau-Mont-Royal borough.
