ORDINANCES

Notice is hereby given that the following ordinances were enacted by the Côte-des-Neiges-Notre-Dame-de-Grâce Borough Council at its regular meeting held on June 1, 2020.

BY-LAW CONCERNING NOISE (R.B.C.M., c. B-3, article 20)

Ordinance OCA20 17013 authorizing the use of amplifiers outdoors, from June 2 to September 7, 2020 on the extension of southbound chemin de la Côte-des-Neiges between chemin Queen-Mary and rue du Frère-André.

BY-LAW CONCERNING TRAFFIC AND PARKING (R.B.C.M., c. C-4.1, article 3, paragraph 8)

- Ordinance OCA20 17011 authorizing the closure of the extension of southbound chemin de la Côte-des-Neiges between chemin Queen-Mary and rue du Frère-André, from June 2 to September 11, 2020 and authorizing the occupancy of parking spaces and part of the sidewalk in front of each of the businesses located on the ground floor or in the basement and which are affected by the closure, from June 2 to October 31, 2020.
- Ordinance OCA20 17017 establishing the traffic manoeuvres allowed at the intersection of rue Jean-Brillant and avenue Decelles, as part of the pedestrian and shared street project on rue Jean-Brillant.

BY-LAW CONCERNING PEACE AND ORDER ON PUBLIC PROPERTY

(R.B.C.M., c. P-1, articles 3 and 8)

- ➢ Ordinance OCA20 17012 authorizing the sale of promotional products, food, alcoholic or non-alcoholic beverages and the consumption of such alcoholic beverages from June 2 to October 31, 2020 on the extension of southbound chemin de la Côte-des-Neiges between chemin Queen-Mary and rue du Frère-André.
- ➤ Ordinance OCA20 17014 authorizing the sale of fruit and vegetables in Nelson Mandela park and in Place de Darlington by the travelling social market of the Multicaf community cafeteria (MultiCaf) in 2020.
- Ordinance OCA20 17015 authorizing the sale of fruit and vegetables in Georges Saint-Pierre and Herbert Outerbridge parks and authorize the occupancy of the Walkley Centre grounds for the same purpose by the Depot Community Food Centre's Good Food Market in 2020.

BY-LAW ON FEES (RCA19 17328)

Ordinance OCA20 17016 authorizing allowing the use, free of charge, of the outdoor tennis courts in Martin Luther King and Somerled parks, until October 12, 2020 and the use, free of charge, of the Doug Harvey arena by the Depot Community Food Centre from April 24 to August 1, 2020, inclusive.
