
Draft resolution CA20 170065 approving specific proposal PP-118 so as to authorize the demolition of the building located at 2585 chemin Bates, and the construction of a six-storey residential building with over 36 units, under the *By-law on specific construction, alteration or occupancy proposals for an immovable* (RCA02 17017) – File No. 1193558040

NOTICE is hereby given by the undersigned that draft resolution CA20 170065 approving specific proposal PP-118, described above, was adopted by the Borough Council at its regular meeting on March 11, 2020 and will be submitted for a 30-day written consultation period starting today, in accordance with ministerial orders 2020-008 and 2020-033 and resolution CA20 170182.

THAT the purpose of this draft resolution is to:

- authorize the demolition of the existing building
- authorize a height of 6 storeys, notwithstanding the provisions allowing only 5 storeys
- authorize the H.7 use (residence with more than 36 units)
- authorize a building line of approximately 0 metres on avenue Wilderton and approximately 2.5 metres on chemin Bates (no reference buildings)
- authorize a maximum number of parking spaces (fewer than 1 space for 22 units)

THAT this draft by-law concerns zone 0807 illustrated below:



THAT this draft resolution is subject to approval by referendum.
