### **WRITTEN PUBLIC CONSULTATION**

#### **Application for a minor exemption**

**4101-03 avenue Old Orchard**

NOTICE is hereby given by the undersigned that the Borough Council, at its regular meeting at 7 p.m. on June 22, 2020, authorized the replacement of the possibility for any interested person to be heard by the Borough Council in relation to the application for a minor exemption (section 145.6 of the *Act respecting land use planning and development*, CQLR, c. A-19.1) with a 30-day written consultation.

In accordance with ministerial orders 2020-008 and 2020-003 and resolution CA20 170180, this application will be submitted for a 30-day written consultation period, starting today.

This minor exemption would make it possible to create two lots with an area 20% less than the average area of serviced lots on the same side of the street, and with an attached mode of building coverage, for the building at 4101–4103 avenue Old Orchard, notwithstanding article 12 of the *By-law concerning cadastral operations* (RBCM, c. 0-1), since the lots will have an area 20% less than the lots on the same side of the street, between the two closest side streets or lanes or facing a dead-end street, in a residential sector, and article 46 of the *Urban planning by-law for Côte-des-Neiges–Notre-Dame-de-Grâce borough (01-276)*, which stipulates that only detached or semi-detached modes of building coverage are authorized.

Any person may submit comments or questions in writing concerning this application for a minor exemption between Monday, July 6, 2020 and 4:30 p.m. on Wednesday, August 5, 2020 as follows :

A videoconference consultation session will be held at 6:30 p.m. on August 5, 2020, at which time the borough will hear individuals who wish to speak on this matter.
