ORDINANCES

Notice is hereby given that the following ordinances were enacted by the Côte-des-Neiges–Notre-Dame-de-Grâce Borough Council at its regular meeting held on September 8, 2020.

BY-LAW CONCERNING NOISE (R.B.C.M., c. B-3, article 20)

- Ordinance OCA20 17031 authorizing the use of amplifiers outdoors property during the commercial promotional events requested by the Commercial development corporation Expérience Côte-des-Neiges.
- Ordinance OCA20 17032 authorizing the use of amplifiers outdoors during the commercial promotional events requested by the Notre-Dame-de-Grâce Business Association.
- Ordinance OCA20 17033 authorizing the use of amplifiers outdoors on the sites and at the dates indicated in Table 1.
- Ordinance OCA20 17039 authorizing the use of amplifiers outdoors on the Placette Côte-des-Neiges.

BY-LAW CONCERNING EXEMPTIONS RESPECTING PARKING UNITS (5984 amended)

URBAN PLANNING BY-LAW FOR CÔTE-DES-NEIGES–NOTRE-DAME-DE-GRÂCE BOROUGH (01-276, article 515)
