- 4174, avenue d'Oxford - Demolition of a garage (application #3002038656)

### ACCESS TO THE VIDEOCONFERENCE

### WRITTEN CONSULTATION

Under Ministerial order 2020-049 of July 4, 2002, any procedure calling for travel or gatherings of citizens may be replaced by a 15-day written consultation period, announced in advance by a public notice. The Côte-des-Neiges–Notre-Dame-de-Grâce Borough Council authorized this replacement procedure at its regular meeting on September 8, 2020, by resolution CA20 170229.

Consequently, and in accordance with the above-mentioned order, **a 15-day written consultation period will be held from September 23 to October 7, 2020 at 4:30 p.m. inclusive.** Written comments may be submitted:
