

PUBLIC NOTICE PUBLIC CONSULTATION MEETING

The Borough of Saint-Laurent of the City of Montreal will hold a written consultation on the object and consequences of the modifications to the by-laws **RCA08-08-0001** on zoning. The first draft by-law **RCA08-08-0001-133** was adopted on **February 2**nd, **2021**.

The first draft by-law RCA08-08-0001-133, modifying by-law number RCA08-08-0001 on zoning, aims to amend the following provisions:

- Specify the description of the "Multiplex (h3)" use;
- Add Cavendish Boulevard to the list of traffic lanes whose adjacent lots are subject to noise mitigation measures;
- Specify the posting standards applicable to site fences;
- Update the zones subject to PIIA 8.55 "Industrial or commercial sector adjacent to a service road, a highway or an artery";
- Specify the objectives and criteria of the PIIA applicable to the Thimens / Lucien-Thimens Sector, namely zones H12-075, H12-048, C12-050 and C12-049;
- Adjust the "Land use coefficient (COS)" report in line with the "Built-up space / land (TOS)" report in the following zones: S03-027, H03-022, H03-025, I05-018, I05 -029, I10-005, I10-012, S11-016, C11-019, H12-084, S13-063, H15-006, H15-008, H15-009, H15-011, H15-074, H15-079, H15-080, H15-095, H15-105 and S16-032;
- Add appendix F "PIIA applicable to land adjacent to a service road, a highway or an artery";
- Make some minor administrative corrections.

These provisions are subject to referendum approval. A request can come from zones H12-075, H12-048, C12-050, C12-049, S03-027, H03-022, H03-025, I05-018, I05-029, I10-005, I10-012, S11-016, C11-019, H12-084, S13-063, H15-006, H15-008, H15-009, H15-011, H15-074, H15-079, H15-080, H15-095, H15- 105 and S16-032 and all areas adjacent to them.

Under Ministerial Decree 2020-033 of May 7th, 2020, any procedure involving the movement or gathering of citizens must be replaced by a written consultation lasting 15 days, announced in advance by a public notice.

Thus, any person can send written comments, by email or by mail, for 15 days following the publication of the notice concerning the draft regulatory amendments, from **February 4th to 18th, 2021**, so that the council can assess their value before rendering a decision.
