



## COMING INTO FORCE OF BY-LAWS

**Notice is given that the following by-laws were adopted at the city council meeting of September 27, 2021:**

- 21-037 Règlement modifiant le Règlement concernant la paix et l'ordre sur le domaine public (R.R.V.M., chapitre P-1) et le Règlement intérieur de la Ville sur la délégation de pouvoirs du conseil de la ville aux conseils d'arrondissement (02-002)**  
[By-law amending the By-law concerning peace and order on public property (R.B.C.M., chapter P-1) and the By-law concerning the delegation of city council powers to borough councils (02-002)]  
The amendments to P-1 clarify in particular the concept of shared terrace and set out an ordinance power under which alcohol consumption is authorized with meals on shared terraces. The purpose of the amendments to by-law 02-002 is to delegate the power to borough councils.
- 21-038 Règlement modifiant le Règlement interdisant la distribution de certains sacs d'emplettes dans les commerces de détail (16-051) et le Règlement intérieur de la Ville sur la délégation de pouvoirs du conseil de la ville aux conseils d'arrondissement (02-002)**  
[By-law amending the By-law prohibiting the distribution of certain shopping bags in retail stores (16-051) and the By-law concerning the delegation of city council powers to borough councils (02-002)]  
The purpose of the amendments to by-law 16-051 is to ban the distribution of plastic bags in retail stores, restaurants as well as for home deliveries. The amendments to by-law 02-002 provide for the enforcement of 16-051 by the boroughs.
- 21-040 Règlement interdisant la distribution de certains articles à usage unique**  
[By-law prohibiting the distribution of certain single-use items]  
The ban concerns establishments that provide restaurant service or package and distribute food to consumers on site.
- 06-051-7 Règlement modifiant le Règlement sur la procédure d'assemblée et les règles de régie interne du conseil municipal (06-051)**  
[By By-law amending the By-law concerning rules of procedure for council meetings and internal rules for council management (06-051)]  
The main purpose of the amendments is to include the process for taking part in the public question period electronically.
- 21-041 Règlement sur la vente et l'utilisation des pesticides**  
[By-law concerning pesticide sales and use]  
The by-law takes effect on January 1, 2022 and repeals, as of that date, the By-law concerning pesticide use (04-041) (as well as all ordinances adopted thereunder).

- 04-061-2 Règlement modifiant le Règlement sur la Commission de la fonction publique de Montréal (04-061)**  
[By-law amending the By-law concerning the Commission de la fonction publique de Montréal (04-061)]  
The amendments concern the rules for assessing skills and sharing with the Service des ressources humaines information relating to complaints.
- 21-042 Règlement sur la divulgation et la cotation des émissions de gaz à effet de serre des grands bâtiments**  
[By-law concerning greenhouse gas emission disclosures and ratings of large buildings]
- 21-041-2 Règlement modifiant le Règlement visant à améliorer l'offre en matière de logement social, abordable et familial (20-041)**  
[By-law amending the By-law to improve the supply of social, affordable and family housing (20-041)]  
The purpose of the amendments is to replace schedule B to add affordable housing areas in several boroughs.
