#### **BY-LAW CONCERNING TRAFFIC AND PARKING (R.B.C.M., c. C-4.1, article 3, paragraph 8)**

- Ordinance OCA21 17059 authorizing the installation of a mandatory stop on avenue Ellendale, heading northeast, at the intersection with avenue Mcshane.

#### **BY-LAW CONCERNING COMMERCIAL PROMOTIONS (R.B.C.M., c. P-11 modified by RCA20 17341, article 17.4)**
