TO INTERESTED PERSONS HAVING THE RIGHT TO APPLY TO PARTICIPATE IN A REFERENDUM (OPENING OF THE REGISTER)

REGISTRATION PROCEDURE FOR PERSONS ELIGIBLE TO VOTE - WRITTEN REQUEST SECOND DRAFT BY-LAW RCA08-08-0001-146

Following the public presentation session by webinar on December 20, 2021 and the written public consultation held from December 8 to 22, 2021, the Saint-Laurent Borough Council adopted, at the regular meeting of January 11, 2022, the second draft by-law number **RCA08-08-0001-146** modifying by-law RCA08-08-0001 on zoning.

This second draft contains the following provisions which may be the subject of a request from interested persons so that a by-law or resolution containing them be submitted for their approval, in accordance with the Law on elections and referendums in municipalities

The second draft by-law number RCA08-08-0001-146 amending by-law number RCA08-08-0001 on zoning aims to:

- increase the maximum number of establishments with a gross floor area of less than 2000 m2 from seven to thirteen establishments;
- allow the development of an outdoor waste storage space comprising a maximum of four semi-buried containers;
- adjust the display standards relating to the attached perpendicular sign.

The provision regarding the number of establishments is subject to referendum approval affecting the areas and affects the delimited C12-021 area:

- To the north by Rue Grenet;
- To the south by Boulevard Marcel-Laurin;
- To the west by rue Poirier;
- To the east by the lateral property line located at 1475, boulevard Marcel-Laurin.

Under ministerial decree 2020-033 of May 7, 2020, any procedure that involves the movement or gathering of citizens must be replaced by a written consultation, announced in advance by a public notice.

Thus, any person can submit written comments, by email or by mail, for 15 days following the publication of the notice concerning the regulations, specifically from **January 12 to 26, 2022**.

A written request must:

- indicate the title of the by-law or the number of the targeted zone as well as the name, address and position of the person qualified to vote who submits it;
- be accompanied by a copy of one of the following documents prescribed to establish his identity, either:
 - o health insurance card issued by the Régie de l'assurance-maladie du Québec;
 - o driver's license or probationary license issued in plastic form by the Société de l'assurance automobile du Québec;
 - Canadian passport;
 - o Indian status certificate;
 - o Canadian Forces ID card.
- be received at the Borough's secretary office, namely:
 - By email indicating in the subject line "Written request in lieu of register (enter the by-law number)" to the following address: benoit.turenne@montreal.ca; or
 - By mail indicating in the subject line "Written request in lieu of register (enter the number of the by-law number)" to the following address:

All letters or emails must be received no later than January 26, 2022 at 4:30 p.m.

The draft by-law for which the required number of requests has not been reached will be deemed adopted by those qualified to vote.

The results of the remote registration procedure for qualified voters will be announced at a subsequent borough council meeting or as soon as they become available.



Conditions applied to a person interested in signing an application

Anyone who is not incapable of voting and who meets the following conditions on December 7, 2021:

- be domiciled in the zone from which a request may come; and
- have been domiciled for at least six months in Quebec; or

Any sole owner of a building or sole occupant of a business establishment who is able to vote and who meets the following conditions on December 7, 2021:

 be the owner of a building or occupant of a business establishment located in the zone from which a request may come for at least twelve months; or

Any undivided co-owner of a building or occupant of a business establishment who is not incapable of voting and who meets the following conditions on December 7, 2021:

- be the undivided co-owner of a building or occupant of a business establishment located in the zone from which a request may come for at least twelve months;
- be designated, by means of a power of attorney signed by the majority of the people who have been coowners or occupants for at least twelve months as the one who has the right to sign the request in their name and to be entered on the referendum list, if need be. This power of attorney must be produced before or at the same time as the request.

In the case of a natural person, they must be of legal age, of Canadian citizenship and not be under curatorship.

In the case of a legal person, it is necessary:

• to have appointed from among its members, directors or employees, by resolution, a person who, on December 7, 2021, is of legal age, of Canadian citizenship, who is not under curatorship and is not affected by any inability to vote provided by law.
