



COMING INTO FORCE OF BY-LAWS

Notice is given that the following by-laws were adopted at the city council meeting of January 24, 2022:

- 22-001 Règlement relatif au fardeau fiscal (exercice financier 2022)**
[By-law concerning the tax burden (fiscal 2022)]
The object of the by-law is to set out the portion of the tax burden increase that does not result from the constitution of the city as to the harmonization of tax burdens in the various sectors where the tax burden borne by the aggregate of the units of assessment of a category of immovables for fiscal 2022 is higher than the one borne for fiscal 2021.
- 10-007-6 Règlement modifiant le Règlement relatif au taux du droit de mutation applicable aux transferts dont la base d'imposition excède 500 000 \$ (10-007)**
[By-law amending the By-law concerning the rate of transfer duties applicable to transfers whose basis of imposition exceeds \$500,000 (10-007)]
The object of the amendment is to replace article 2 of the by-law to index the parts of the basis of imposition that exceed \$500,000. A new basis of imposition is added for the part that exceeds \$3,000,000. The by-law takes effect on February 1, 2022.
- 22-004 Règlement sur les tarifs (exercice financier 2022)**
[By-law concerning fees (fiscal 2022)]
- 22-005 Règlement abrogeant le Règlement constituant une réserve foncière pour promouvoir la construction domiciliaire pour un montant maximum de 5 000 000,00 \$ (1291) de l'ancienne Ville de Verdun**
[By-law repealing the by-law titled “Règlement constituant une réserve foncière pour promouvoir la construction domiciliaire pour un montant maximum de 5 000 000,00 \$ (1291)” of the former Ville de Verdun]
The initial purpose of the repealed by-law was to set up a land reserve of a maximum amount of \$5,000,000.00 to facilitate residential construction on the territory of the former Ville de Verdun.
- 22-006 Règlement modifiant le Règlement sur les excavations (R.R.V.M., chapitre E-6)**
[By-law amending the By-law concerning excavations (R.B.C.M., chapter E-6)]
The purpose of the amendment is to extend the scope of the by-law concerning excavations on public property to the territory of Verdun borough. The by-law repeals by-law 1173 of the former Ville de Verdun.

14-012-2 Règlement modifiant le Règlement sur les services (14-012)

[By-law amending the By-law concerning departments (14-012)]

The purpose of the amendments is to integrate the teams of the following departments into the new Service de la planification stratégique et de la performance organisationnelle: the Service de la performance organisationnelle, the Laboratoire d'innovation urbaine de Montréal, the Bureau des projets et programmes d'immobilisations and the Division de la planification stratégique under the Direction générale.

These by-laws come into force January 31, 2022, and may be consulted during regular business hours at the Service du greffe, 155, rue Notre-Dame Est. They are also available at montreal.ca/reglements-municipaux.
