### BY-LAW CA29 0116-2 REGARDING THE REMUNERATION OF THE PIERREFONDS-ROXBORO COUNCIL MEMBERS

This remuneration will be indexed on each fiscal year from the one beginning after its entry into force, on the basis of a percentage corresponding to the rate of increase in the consumer price index for Québec established by Statistics Canada for the previous year.

### BY-LAW MODIFYING BY-LAW CONCERNING THE REMUNERATION OF THE MEMBERS OF THE BOROUGH COUNCIL OF PIERREFONDS-ROXBORO IN ORDER TO ESTABLISH THE ADDITIONAL ANNUAL REMUNERATION OF THE CHAIRMAN OF THE TRAFFIC COMMITTEE

At the Borough of Pierrefonds-Roxboro regular sitting held by videoconference on February 7, 2022 at 7 p.m., in conformity with the Cities and Towns Act (L.R.Q.,Chapter C-19), and in conformity with the ministerial orders by which the minister of Health and Social Services has implemented special measures for the municipalities in order to minimize the spreading risks associated with COVID-19, to which attend:

The Mayor of the Borough Mr. Dimitrios (Jim) Beis, Councillors Catherine Clément-Talbot, Chahi (Sharkie) Tarakjian, Benoit Langevin and Louise Leroux, all members of the Council and forming a quorum under the chairmanship of the Mayor of the Borough, Mr. Dimitrios (Jim) Beis.

The Director of the Borough, Mr. Dominique Jacob, and the Secretary of the Borough, M<sup>e</sup> Alice Ferrandon, also attend by videoconference.

WHEREAS section 2 of the Act respecting the salaries of elected municipal officials (R.S.Q., chapter T-11.001);

WHEREAS section 43 of the Charter of Ville de Montréal (R.S.Q., chapter C-11.4);

THE BOROUGH COUNCIL ENACTS THE FOLLOWING:

ARTICLE 1

Add section 2.1 after section 2 as follows:

"ARTICLE 2.1

The additional annual compensation for the Chairman of the Circulation Committee is set at \$3,795."

### ARTICLE 2

Add to the first paragraph of Article 4 the reference to Article 2.1, as follows:

## "ARTICLE 4

The compensation provided for in sections 1, 2 and 2.1 of this by-law shall be indexed upward, where applicable, for each fiscal year commencing after the effective date of this by-law.

Indexation shall consist of an increase, for each fiscal year of the City, of a percentage corresponding to the rate of increase of the Consumer Price Index for Quebec established by Statistics Canada for the previous year."

### ARTICLE 3

This by-law comes into force in accordance with the Law.
