TO INTERESTED PERSONS HAVING THE RIGHT TO APPLY TO PARTICIPATE IN A REFERENDUM (OPENING OF THE REGISTER)


REGISTRATION PROCEDURE FOR PERSONS ELIGIBLE TO VOTE - WRITTEN REQUEST SPECIALS PROJECTS FOR THE CONSTRUCTION, MODIFICATION OR OCCUPANCY OF A BUILDING (PPCMOI) OF 1070, RUE O'BRIEN AND 720-750, RUE OUIMET

Following the public presentation session by webinar on February 23, 2022 and which followed the written public consultation held from February 9 to 23, the Borough of Saint-Laurent adopted, at the regular meeting of March 1 2022, the second draft resolutions approving specific projects (PPCMOI) located at **1070**, avenue O'Brien and at **720-750**, rue Ouimet.

The second draft resolution for the PPCMOI of 1070, avenue O'Brien will seek to authorize the use "2221-07 general repair" as the main use in the building located at 1070, avenue O'Brien, under the Bylaw concerning projects construction, modification or occupation of a building (RCA10-08-5).

These provisions are subject to referendum approval and affect the areas H16-003.

A request can come exclusively from areas C16-020, S16-019, C16-018, C16-021, S16-027 et H16-029.






The second draft resolution for the PPCMOI of 720-750, rue Ouimet will aim to authorize the construction of a 3-storey residential building on lot no. 2 190 496 under the By-law concerning special projects for the construction, modification or occupation of an immovable (RCA10-08-5).

These provisions are subject to referendum approval and affect the areas H16-003.

A request can come exclusively from areas H16-003, S16-002, H13-085, H13-030, H16-004, S16-005 et S16-009.



Under Ministerial Decree 2020-033 of May 7, 2020, any procedure that involves the movement or gathering of citizens must be replaced by a written consultation, announced in advance by a public notice.

Thus, any person can submit written comments, by email or by mail, for 15 days following the publication of the notice concerning the regulations, from **March 9 to March 23, 2022.**

A written request must:

- indicate the title of the by-law or the number of the targeted zone as well as the name, address and position of the person qualified to vote who submits it;
- be accompanied by a copy of one of the following documents prescribed to establish his identity, either:
 - o health insurance card issued by the Régie de l'assurance-maladie du Québec;
 - o driver's license or probationary license issued in plastic form by the Société de l'assurance automobile du Québec;
 - Canadian passport;
 - o Indian status certificate;
 - o Canadian Forces ID card.
- be received at the Borough's secretary office, namely:
 - By email indicating in the subject line "Written request in lieu of register (enter the by-law number)" to the following address: benoit.turenne@montreal.ca; or
 - By mail indicating in the subject line "Written request in lieu of register (enter the number of the by-law number)" to the following address:

All letters or emails must be received no later than March 23, 2022 at 4:30 p.m.

The draft by-law for which the required number of requests has not been reached will be deemed adopted by those qualified to vote.

The results of the remote registration procedure for qualified voters will be announced at a subsequent borough council meeting or as soon as they become available.

Conditions applied to a person interested in signing an application

Anyone who is not incapable of voting and who meets the following conditions on February 1, 2022:

- be domiciled in the zone from which a request may come; and
- have been domiciled for at least six months in Quebec; or

Any sole owner of a building or sole occupant of a business establishment who is able to vote and who meets the following conditions on February 1, 2022:

• be the owner of a building or occupant of a business establishment located in the zone from which a request may come for at least twelve months; or

Any undivided co-owner of a building or occupant of a business establishment who is not incapable of voting and who meets the following conditions on February 1, 2022:

- be the undivided co-owner of a building or occupant of a business establishment located in the zone from which a request may come for at least twelve months;
- be designated, by means of a power of attorney signed by the majority of the people who have been co-owners or occupants for at least twelve months as the one who has the right to sign the request in their name and to be entered on the referendum list, if need be. This power of attorney must be produced before or at the same time as the request.

In the case of a natural person, they must be of legal age, of Canadian citizenship and not be under curatorship.

In the case of a legal person, it is necessary:

• to have appointed from among its members, directors or employees, by resolution, a person who, on February 1, 2022, is of legal age, of Canadian citizenship, who is not under curatorship and is not affected by any inability to vote provided by law.
