BY-LAW CONCERNING NOISE (R.B.C.M., c. B-3, article 20)

- Ordinance OCA22 17003 authorizing the use of amplifiers outdoors on the sites and at the dates indicated in Table 1.

BY-LAW CONCERNING TRAFFIC AND PARKING

(R.B.C.M., c. C-4.1, article 3, paragraph 8)
