### ORDINANCES

Notice is hereby given that the following ordinances were enacted by the Côte-des-Neiges–Notre-Dame-de-Grâce Borough Council at its regular meeting held on April 4, 2022.

#### **BY-LAW CONCERNING NOISE** (R.B.C.M., c. B-3, article 20)

- Ordinance OCA22 17007 authorizing the use of amplifiers outdoors on the sites and at the dates indicated in Table 1.
