



COMING INTO FORCE OF BY-LAWS

Notice is given that the following by-laws were adopted at the city council meeting of August 22, 2022:

- 17-077-2 Règlement modifiant le Règlement sur la subvention relative à l'abattage de frênes et à leur remplacement (17-077)**
[By-law amending the By-law concerning the subsidy for felling ash trees and their replacement (17-077)]
The by-law amends several of the program's parameters, specifically the subsidy amount granted as well as the application eligibility period.
- 15-063-4 Règlement modifiant le Règlement sur la subvention relative au traitement des frênes situés sur des propriétés privées (15-063)**
[By-law amending the By-law concerning the subsidy for the treatment of ash trees located on private property (15-063)]
The purpose of the by-law is to repeal the provision allowing applicants to submit applications for the program by mail, in paper format.
- 15-040-3 Règlement modifiant le Règlement relatif à la lutte contre l'agrile du frêne sur le territoire de la ville de Montréal (15-040)**
[By-law amending the By-law concerning the fight against the emerald ash borer on the territory of Montréal (15-040)]
The purpose of the amendments is specifically to extend the validity period for tree-felling authorization certificates.
- 22-033 Règlement sur la fermeture d'une ruelle située au nord-est de la rue Saint-Donat, entre la rue De Teck et la rue de Marseille, dans l'arrondissement de Mercier–Hochelaga-Maisonneuve, aux fins de transfert aux propriétaires riverains**
[By-law to close a lane located northeast of Rue Saint-Donat, between Rue De Teck and Rue de Marseille, in Mercier–Hochelaga-Maisonneuve borough, for the purposes of transfer to bordering owners]
- 14-036-4 Règlement modifiant le Règlement sur la subvention municipale à la rénovation et à la démolition-reconstruction résidentielles (14-036)**
[By-law amending the By-law concerning the municipal subsidy for residential renovation and demolition-reconstruction (14-036)]
The by-law amends the reference in article 36 to the setting of rents under the “demolition-reconstruction” component of the program.

02-002-39 Règlement modifiant le Règlement intérieur de la Ville sur la délégation de pouvoirs du conseil de la ville aux conseils d'arrondissement (02-002)

[By-law amending the By-law concerning the delegation of city council powers to borough councils (02-002)]

The purpose of the amendments is to specify that the enforcement of by-laws concerning transfers for park purposes (by-law 17-055) which is delegated to boroughs allows them to take all actions necessary for the use of sums and land obtained under that by-law.

20-041-4 Règlement modifiant le Règlement visant à améliorer l'offre en matière de logement social, abordable et familial (20-041)

[By-law amending the By-law to improve the supply of social, affordable and family housing (20-041)]

The purpose of the by-law is to replace schedule B in order to add affordable housing areas in Ahuntsic-Cartierville, Ville-Marie and Saint-Léonard boroughs. Technical corrections are also made.

These by-laws come into force August 29, 2022, and may be consulted during regular business hours at the Service du greffe, 155, rue Notre-Dame Est. They are also available at montreal.ca/reglements-municipaux/.
