

COMING INTO FORCE OF BY-LAWS

Notice is given that the following by-laws were adopted at the city council meeting of November 21, 2022:

07-053-5 **Règlement modifiant le Règlement du conseil de la ville sur la subdélégation de certains pouvoirs relatifs à des équipements, infrastructures et activités d'intérêt collectif identifiés à l'annexe du Décret concernant l'agglomération de Montréal (1229-2005, 8 décembre 2005) (07-053)**

[By-law amending the By-law concerning the subdelegation of certain city council powers relating to facilities, infrastructures and activities of collective interest listed in the schedule to the Order in Council respecting the urban agglomeration of Montréal (1229-2005, December 8, 2005) (07-053)]

The purpose of the amendments is to subdelegate to the boroughs the maintenance of the urban agglomeration bicycle path network located on their respective territories.

03-108-10 **Règlement modifiant le Règlement intérieur du conseil de la ville portant délégation aux conseils d'arrondissement de certains pouvoirs relatifs aux sociétés de développement commercial (03-108)**

[By-law amending the By-law concerning the delegation to borough councils of certain powers relating to commercial development associations (03-108)]

The amendments make the necessary adjustments for the purposes of by-law 22-047 mentioned below. The by-law takes effect on January 1, 2023.

22-047 **Règlement établissant les modalités de versement des cotisations aux sociétés de développement commercial pour les années budgétaires 2023 et 2024 ainsi que les moyens de transmission des avis de convocation aux assemblées générales**

[By-law establishing the payment modes for contributions to commercial development associations for the 2023 and 2024 budget years and the notices of annual general meetings delivery methods]

The by-law takes effect on January 1, 2023.

22-048 **Règlement autorisant la construction et l'occupation d'un bâtiment situé sur le lot 1 437 257 du cadastre du Québec à des fins d'hébergement dans le cadre d'un projet destiné aux personnes ayant besoin d'aide**

[By-law authorizing the construction and occupancy of a building located on lot 1 437 257, cadastre of Québec, for housing purposes, as part of a project for persons in need of assistance]

02-002-40 Règlement modifiant le Règlement intérieur de la Ville sur la délégation de pouvoirs du conseil de la ville aux conseils d'arrondissement (02-002)

[By-law amending the By-law concerning the delegation of city council powers to borough councils (02-002)]

The purpose of the amendments is to expand the delegation of powers over street food to the boroughs as well as the delegation related to the enforcement of any by-law concerning the distribution of advertising items.

17-055-1 Règlement modifiant le Règlement relatif à la cession pour fins d'établissement, de maintien et d'amélioration de parcs, de terrains de jeux et de préservation d'espaces naturels sur le territoire de la Ville de Montréal (17-055)

[By-law amending the By-law concerning the transfer for purposes of establishing, maintaining and improving parks and playgrounds and of preserving natural areas on city territory (17-055)]

The amendments specify several aspects of the by-law, including the title, interpretations as well the parts of immovables that must be taken into account for a mixed-use project.

All these by-laws come into force November 29, 2022, and may be consulted during regular business hours at the Service du greffe, 155, rue Notre-Dame Est. They are also available at montreal.ca/reglements-municipaux/.
