

COMING INTO FORCE OF BY-LAWS

Notice is given that the following by-laws were adopted at the city council meeting of December 19, 2022:

- 22-051** **Règlement relatif au fardeau fiscal (exercice financier 2023)**
[By-law concerning the tax burden (fiscal 2023)]
The object of the by-law is to set out the portion of the tax burden increase that does not result from the constitution of the city as to the harmonization of tax burdens in the various sectors where the tax burden borne by the aggregate of the units of assessment of a category of immovables for fiscal 2023 is higher than the one borne for fiscal 2022.

- 22-053** **Règlement concernant la taxe foncière sur les parcs de stationnement (exercice financier 2023)**
[By-law concerning property taxes on parking lots (fiscal 2023)]
- 10-007-7** **Règlement modifiant le Règlement relatif au taux du droit de mutation applicable aux transferts dont la base d'imposition excède 500 000 \$ (10-007)**
[By-law amending the By-law concerning the rate of transfer duties applicable to transfers whose basis of imposition exceeds \$500,000 (10-007)]
The object of the amendment is to replace article 2 of the by-law to index the parts of the basis of imposition that exceed \$500,000. The by-law takes effect January 1, 2023.

[By-law concerning fees (fiscal 2023)]
- 22-055** **Règlement relatif à la tarification de l'eau fournie aux immeubles non résidentiels (exercice financier 2023)**
[By-law concerning the tariffing of water supplied to non-residential immovables (fiscal 2023)]
- 03-009-14** **Règlement modifiant le Règlement intérieur du conseil sur la délégation de pouvoirs au comité exécutif (03-009)**
[By-law amending the By-law concerning the delegation of city council powers to the executive committee (03-009)]
The object of the by-law is to delegate to the executive committee the power to remove an immovable from public property for alienation, where the immovable is valued at \$150,000 or less.

18-020-3 Règlement modifiant le Règlement fixant le montant des amendes à l'égard des infractions en matière de stationnement ou d'immobilisation des véhicules (18-020)

[By-law amending the By-law concerning vehicle parking or immobilization fines (18-020)]

The purpose of the amendments is to increase the amount of the fines set out in the by-law.

All these by-laws come into force December 23, 2022, except for by-law 18-020-3 which will come into force January 16, 2023, and may be consulted during regular business hours at the Service du greffe, 155, rue Notre-Dame Est. They are also available at montreal.ca/reglements-municipaux/.
